BILL OF SALE AND ASSIGNMENT OF ASSETS

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and sufficiency of which are hereby acknowledged, Seller hereby sells, assigns, transfers, conveys, grants and delivers to Buyer, pursuant to the terms and conditions of that certain Agreement for Purchase and Sale of Assets, dated for reference purposes as of October 9, 2009 (the "Asset Purchase Agreement"), by and between Seller and Buyer, all of Seller's right, title and interest in and to the Assets to be sold (the "Assets"), including, without limitation, those items, assets, properties and rights listed on Exhibits 4.2, 7.1, 7.2 and 8, plus Schedule 23(q) attached hereto or otherwise owned or held by Seller and used in the operation of the Business, but excluding the Excluded Assets.

Seller hereby covenants and agrees that it will execute and deliver such documents as may be useful or necessary to evidence and effect the sale, assignment, transfer, conveyance, grant and delivery of the purchased Assets to Buyer.

This Bill of Sale may be assigned by Buyer to any subsequent purchaser or transferee of the purchased Assets.


