NOW THEREFORE, in consideration of good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, the Transferor confirms that it has assigned, transferred and conveyed, and by these presents does assign, transfer and convey to the Transferee, whose principal office or place of business is 2050 rue de Bleury, Suite 300, Montreal H3A 2J5 QUEBEC, the whole right, title and interest in and to the said IP Rights and any applications or registrations therefor, together with the goodwill of the business connected

with the use of and symbolized by said IP Rights and the right to take action and recover in respect of any infringement and/or passing off that took place prior to the date of the transfer.
