Release of Lien on Trademarks

This Release of Lien on Trademarks (the "Release"), dated as of November 23, 2009 is made by Wachovia Bank, National Association ("Bank"), located at 150 Fayetteville Street, Suite 600, Raleigh, North Carolina 27602, as administrative agent ("Agent") for the financial institutions party to the Credit Agreement, dated as of August 28, 2009, among TowerCo Finance LLC, TowerCo II Holdings LLC, the financial institutions party thereto and the Agent, in favor of TowerCo Staffing, Inc., a Delaware corporation ("Grantor"), located at 5000 Valleystone Drive, Suite 200, Cary, North Carolina, 27519.

WHEREAS, Grantor entered into a Trademark Security Agreement, dated as of August 28, 2009 and recorded in the United States Patent and Trademark Office as of August 31, 2009 at Reel 4054, Frame 0926 (the "Trademark Security Agreement"), pursuant to which Grantor granted, pledged and collaterally assigned to the Agent a security interest in and lien on all right, title and interest of the Grantor in all of Grantor's trademarks, including the trademark registrations and applications set forth on Schedule A attached hereto (the "Released Trademarks") to secure the performance of certain obligations (the "Obligations");

WHEREAS, the Obligations have now been satisfied, Grantor has requested that the Agent release any and all interest it may have in the Released Trademarks, and the Agent has agreed to do so.

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby release, relinquish and discharge its security interest in, to and under the Released Trademarks, including, for the avoidance of doubt, all other rights and property granted, pledged and collaterally assigned by Grantor under the Trademark Security Agreement.

THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS RELEASE SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NORTH CAROLINA.
