**CONFIRMATORY TRADEMARK ASSIGNMENT**

WHEREAS, J.H. Nevada, Inc. is a corporation duly organized and existing under the laws of the State of Nevada having a place of business at 11 East 26<sup>th</sup> Street, 4<sup>th</sup> Floor, New York, NY 10010 (hereinafter "Assignor");

WHEREAS, James Hotel Management Company, LLC is a limited liability company duly organized and existing under the laws of the State of Delaware having a place of business at c/o Denihan Hospitality Group, 500 West 37<sup>th</sup> Street, New York, NY 10018 ("Assignee");

WHEREAS, Assignor and Assignee entered into a Trademark Conveyance Agreement dated December 21, 2007 ("Agreement"), in connection with which they executed an Assignment of Trademarks on January 3, 2008 ("Assignment") which Assignment was recorded in the United States Patent and Trademark Office ("USPTO") on May 28, 2008 at Reel 3784/Frame 583 against eight (8) properties;

WHEREAS, the parties inadvertently omitted a property from said Assignment, namely Application Serial No. 77/337,397 ("Application") for the mark LUXURY LIBERATED ("Trademark") filed in the USPTO on November 27, 2007;


WHEREAS, the parties wish to record this Confirmatory Assignment in the USPTO against the Trademark to reflect that, as least as early as December 21, 2007, Assignor assigned to Assignee all of its right, title and interest in the Trademark, including the Application, together with the goodwill of the business symbolized by the Trademark, in accordance with Section 10 of the Lanham Act, 15 U.S.C. §1060;

NOW, THEREFORE, in consideration of the foregoing premises and the mutual covenants and agreements contained herein, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Assignor does hereby sell, assign and transfer unto Assignee, effective on or before December 21, 2007, all right, title and interest in and to the Trademark, including the Application, and together with the good will of the business in which the mark pertains and is used, and with that part of the good will of the business connected with the use of and symbolized by the mark, which is ongoing and existing.

2. Assignor shall do all acts and execute all documents which may be reasonably required by Assignee in order to effect the assignment to Assignee of its rights in the Trademark, and the Application.
