INTELLECTUAL PROPERTY SECURITY RELEASE

This Intellectual Property Security Release (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*IP Security Release*") dated November 25, 2009, is made by CITICORP NORTH AMERICA, INC., as collateral agent (the "*Collateral Agent*") for the Secured Parties (as defined in the Credit Agreement referred to below), in favor of TD AMERITRADE HOLDING CORPORATION (formerly AMERITRADE HOLDING CORPORATION), TD AMERITRADE ONLINE HOLDINGS CORP. (formerly, Ameritrade Online Holdings Corp. and successor to Datek Online Holdings Corp. and TD Waterhouse Group, Inc.), TD AMERITRADE IP COMPANY, INC. (formerly, Ameritrade IP Company, Inc.), TD AMERITRADE SERVICES COMPANY, INC. (formerly Ameritrade Services Company, Inc.), THINKTECH, INC., THINKORSWIM GROUP INC. and THINKORSWIM HOLDINGS INC. (collectively, the "*Grantors*"). All capitalized terms used herein but not otherwise defined herein shall have the meanings ascribed to those terms in Credit Agreement, the IP Security Agreement, the TD Waterhouse IP Security Agreement Supplement and the Thinkorswim IP Security Agreement Supplements (each as defined below).

WHEREAS, TD AMERITRADE Holding Corporation (formerly Ameritrade Holding Corporation), a Delaware corporation, entered into a Credit Agreement dated as of January 23, 2006 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*Credit Agreement*"), with The Bank of New York Mellon, as Administrative Agent, Citicorp North America Inc., as Collateral Agent, the other agents party thereto and the Lender Parties party thereto;

WHEREAS, pursuant to the Credit Agreement, the Grantors and certain other Persons have executed and delivered that certain Security Agreement dated January 23, 2006 made by the Grantors and such other Persons to the Collateral Agent (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*Security Agreement*");

WHEREAS, under the terms of the Security Agreement, the Grantors granted to the Collateral Agent, for the ratable benefit of the Secured Parties, a security interest in, among other property, certain intellectual property of the Grantors, and executed and delivered (i) that certain Intellectual Property Security Agreement dated January 23, 2006 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "*IP Security Agreement*"), (ii) that certain Intellectual Property Security Agreement Supplement, dated January 24, 2006 (the "*TD Waterhouse IP Security Agreement Supplement*") and (iii) those certain Intellectual Property Security Agreement Supplements, both dated July 10, 2009 (collectively the "*Thinkorswim IP Security Agreement Supplements*");

WHEREAS, the IP Security Agreement was recorded with the Patent Division of the United States Patent and Trademark Office on February 3, 2006 at Reel 017115 and Frame 0509; with the Trademark Division of the United States Patent and Trademark Office on February 3, 2006 at Reel 3240 and Frame 0512; and with the United States Copyright Office on February 14, 2006 in Volume 3535 and Document No. 050;

WHEREAS, the TD Waterhouse IP Security Agreement Supplement was recorded with the Trademark Division of the United States Patent and Trademark Office on February 6, 2006 at Reel 3240 and Frame 0949;

WHEREAS, the Thinkorswim IP Security Agreement Supplements were recorded with the Patent Division of the United States Patent and Trademark Office on July 10, 2009 at Reel 022939 and Frame 0317; and with the Trademark Division of the United States Patent and Trademark Office on July 10, 2009 at Reel 4022 and Frame 0729 and Reel 4022 and Frame 0808; and

WHEREAS, the Collateral Agent now desires to release its security interest in and to the Grantors' right, title and interest in and to the Collateral, including the patents and patent applications set forth in Schedule A hereto, the trademark and service mark registrations and applications set forth in Schedule B hereto, and the copyright registrations and applications set forth in Schedule C hereto (the "*Released Intellectual Property*").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

SECTION 1. Release of Security Interest. The Collateral Agent hereby terminates and releases in its entirety to the Grantors its security interest in, to and under the Released Intellectual Property.



SECTION 3. Governing Law. This IP Security Release shall be governed by, and construed in accordance with, the laws of the State of New York.
