RELEASE OF SECURITY INTEREST

This Release of Security Interest is effective November 06, 2009.

WHEREAS, as security for (a) that certain \$2,500,000 loan made to Debtor (as hereinafter defined) by Sanwa Bank California (predecessor in interest to Bank of the West) pursuant to the terms of that certain Term Loan Credit Agreement dated December 17, 1997, as such loan has been amended to date (the "Term Loan") and (b) that certain \$10,000,000 line of credit loan made to Debtor by Sanwa Bank California (predecessor in interest to Bank of the West) pursuant to the terms of that certain Line of Credit Agreement dated September 03, 1998, as such loan has been amended to date (the "Line of Credit Loan" and, collectively with the Term Loan, the "Loans"). Sanwa Bank California, a California corporation, having a business address at 1280 Fourth Avenue, San Diego, California 92101 (hereinafter referred to as the "Lien Holder"), was granted a first security interest (the "First Security Interest") by EAGLE CREEK, INC., a corporation organized under the laws of the state of California and having a business address at 3055 Enterprise Road, Vista, California 92083 (hereinafter referred to as the "Debtor"), in and to the certain trademarks (the "Trademarks") of the Debtor as set forth on Schedule A, which First Security Interest was made of record in the records of the State of California, Secretary of State in the form of an "Assignment" by Sumitomo Bank of California to Sanwa Bank California on February 10, 1997, file number 97041C0361 of file number of the original financing statement 9433661003.

WHEREAS, Sanwa Bank California (the surviving depository corporation) and Tokai Bank of California (the disappearing depository corporation) merged with the surviving depository corporation having the name United California Bank. UNITED CALIFORNIA BANK was acquired by Bank of the West on April 01, 2002.

WHEREAS, the Lien Holder is desirous of assigning, releasing and quitclaiming to the Debtor any right, title and interest, including without limitation any security interest(s), "granted to secure the Loans" which the Lien Holder may have in and to the Trademarks, and in any continuations, continuations-in-part, or reissue applications claiming priority to the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Lien Holder has assigned, released, quitclaimed, transferred and set over, and by these presents does hereby assign, release, quitclaim and set over unto the Debtor, its successors and assigns, any right, title and interest, including without limitation any security interest(s), which the Lien Holder may have in and to the Trademarks and in any continuations, continuations-in-part, or reissue applications claiming priority to the Trademarks, "which security interest were granted to secure the Loans".

The Lien Holder further agrees, at the Debtor's expense and request, to take all lawful acts which the Debtor may deem reasonably advisable or necessary in order to render this release fully effective and to make this release of record in the U.S. Patent and Trademark Office, and such other government offices as the Debtor may normally select, including without limitation, execution of lawful documents.
