And ASSIGNOR further covenants and agree that it will, at the request and expense of the said ASSIGNEE, execute such other and further assurances of title as may be necessary or proper to fully convey the interest herein sought to be conveyed; that ASSIGNOR will, at the request and expense of the said ASSIGNEE execute such application papers as may be desired by the said ASSIGNEE, for the filing of any divisional or renewal of the application herein conveyed, or for reissues or extensions, of any Trademark that may be granted upon said Statements, or other papers as desired by the said ASSIGNEE.

And ASSIGNOR further assigns unto the said ASSIGNEE, the whole right, title, and interest to the Trademark throughout all countries foreign to the United States, and does hereby


