RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST ("Release") is made effective as of November 24, 2009 by JPMORGAN CHASE BANK, N.A., for itself and as Administrative Agent for the Lenders (the "Administrative Agent"), to ADC TELECOMMUNICATIONS, INC., (the "Borrower"), as follows:
