TRADE MARK ASSIGNMENT

THIS ASSIGNMENT is dated this 23rd day of November 2009

BETWEEN:

(1) **CHRIS KINGSLEY**, Riverside House, Osney Mead, Oxford, United Kingdom OX2 0ES (the "Assignor");

and

(2) **CHRIS KINGSLEY and JASON KINGSLEY** Riverside House, Osney Mead, Oxford, United Kingdom OX2 0ES (the "Assignees").

WHEREAS:

- (A) The Assignor may be, at the date of this Assignment, the proprietor of the international trade marks registered with United States Patent and Trade Mark Office known as REBELLION (number 2845116) (the "Trade Mark").
- (B) The Assignor has agreed to assign all its right, title and interest the Trade Marks to the Assignee on the terms set out in this Assignment and for the consideration mentioned below.

NOW IT IS HEREBY AGREED

1. In this assignment, except where the contrary requires otherwise, the following words and expressions have the following meanings:
 - 1.1 "Trade Mark" means the trade mark applications and registrations listed in the Schedule in the name of the Assignor.
2. In consideration of the sum of £1.00 (ONE POUND STERLING) (the receipt of which sum the Assignor hereby acknowledges) the Assignor hereby assigns to the Assignees absolutely such right, title and interest as the Assignor may have at the date of this Assignment in and to the Trade Marks including:
 - 2.1 any benefit the Assignor may have in any applications for registration with the intention that when the applications are granted the registrations will vest in the Assignees;
 - 2.2 any common law rights and any goodwill attaching to the Trade Mark the Assignor may have; and
 - 2.3 any right the Assignor may have to bring proceedings against any third party in respect of the Trade Mark (including proceedings against any third party for infringement of the Trade Marks or for passing off or for otherwise infringing the rights of the Assignor in the Trade Marks, whether committed before or after the date of this Assignment); and
3. The Assignor agrees and undertakes, if reasonably required, to provide to the Assignees (at its request and expense) all such assistance with any proceedings which may be brought by or against the Assignees against or by any third party in relation to the Trade Mark and the Assignees shall indemnify the Assignor in respect of all costs and expenses (including

- reasonable legal costs) actually incurred by it in providing the Assignee with such assistance.
4. The Assignor covenants that (at the cost and expense of the Assignees) at the request of the Assignee or its nominee, at any time and from time to time, it will promptly execute such deeds or documents and do such acts or things as may be necessary or desirable to give effect to this Assignment.
 5. This Assignment shall be governed by and construed in accordance with the laws of England and the parties hereto submit to the non-exclusive jurisdiction of the English courts.
