## ASSIGNMENT OF TRADEMARKS

This Assignment, dated September 30, 2009, is entered into by TRUSSED, INC., a Delaware corporation (the "Assignor"), for the benefit of HARDY FRAMES, INC., a Delaware corporation (the "Assignee").

**WHEREAS**, Assignee and Assignor have entered into that certain Asset Purchase Agreement of even date herewith (the "Purchase Agreement") wherein Assignor agreed to transfer, assign and convey certain assets of Assignor, including certain general intangibles of Assignor, to Assignee;

**WHEREAS**, pursuant to the Purchase Agreement, Assignor is obligated to assign to Assignee all of its right, title, and interest in and to any Intellectual Property (as defined in the Purchase Agreement) rights related to the Business (as defined in the Purchase Agreement);

**WHEREAS**, Assignor owns the entire, right, title, and interest in and to the U.S. Trademark Registration No. 2,638,029 for Z4 (and Design) for "*construction materials and connection devices for use in new construction and renovation, namely, metal tie downs, metal wall ties, metal compression and tension bolted connections, metal sheer wall connectors, metal exterior ties, metal exterior plates, metal tension only bolted connections or hold downs* in Class 6" (hereinafter referred to as the "Trademark").

**NOW THEREFORE**, Assignor in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, **DOES HEREBY** irrevocably and unconditionally grant sell, bargain, assign, transfer, convey and deliver to Assignee good and valid title, and all of Assignor's right title and interest free and clear of all liens, security interests and other encumbrances, Assignor has in and to the Trademark along with all of the goodwill associated with the Trademark, and the right to sue and recover for infringements occurring prior to this assignment. Assignor represents and warrants that at the time of making this assignment it is the owner of all right, title, and interest in and to the Trademark, and all the goodwill therein; that the Trademark are currently in force; and that it has not licensed, mortgaged, or otherwise transferred any rights in the Trademarks to any person or entity other than Assignee.

**TO HAVE AND TO HOLD** the above-described Trademark, with all of the rights and appurtenances thereto belonging unto Assignee, for itself, its successors and assigns for their own use and behalf forever.

For good and valuable consideration, the sufficiency of which is hereby acknowledged, Assignor covenants that Assignor will do, execute and deliver, or will cause to be done, executed and delivered, all such further reasonable acts, transfers, assignments and conveyances, powers of attorney and assurances, for the better assuring, conveying and confirming unto Assignee, the entire right, title and interest in the Trademark hereby sold, transferred, assigned, and conveyed as Assignee may reasonably require.

This Assignment and covenants and agreements herein contained shall inure to the benefit of Assignee, his successors and assigns, and shall be binding upon Assignor, its successors and assigns.

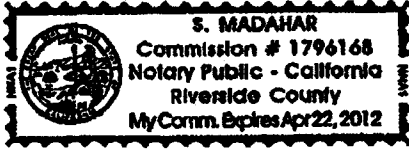

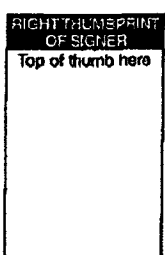
