WHEREAS, ASSIGNOR has adopted and is using the trademarks and trademark application and registrations listed in Schedule A ("Marks");


WHEREAS, ASSIGNEE is desirous of acquiring all rights, title, and interest in and to said Marks and the goodwill of the business associated therewith;


