under Section 805 of the Business Corporation Law

We, Fred B. Parks, President and Chief Executive Officer, and William J. Cull, Sr., Vice President, General Counsel and Secretary, of Marconi Medical Systems, Inc. (the "Corporation"), do hereby certify:

1. The name of the Corporation is Marconi Medical Systems, Inc. The name under which the Corporation was formed was James Picker, Inc.

2. The Certificate of Incorporation was filed by the Department of State on January 6, 1922.

3. The Certificate of Incorporation of the Corporation is hereby amended, pursuant to Section 801(b)(1) of the Business Corporation Law of the State of New York (the "BCL"), to change the name of the Corporation. ARTICLE FIRST of the Certificate of Incorporation, which sets forth the name of the Corporation, is hereby amended by deleting said ARTICLE FIRST and by substituting therefor the following ARTICLE FIRST:

The name of the corporation (hereinafter called the "Corporation") is Philips Medical Systems (Cleveland), Inc.

4. The foregoing amendment was authorized by unanimous written consent of the board of directors and shareholders of all outstanding shares of the Corporation entitled to vote thereon pursuant to Section 615(a) of the BCL.

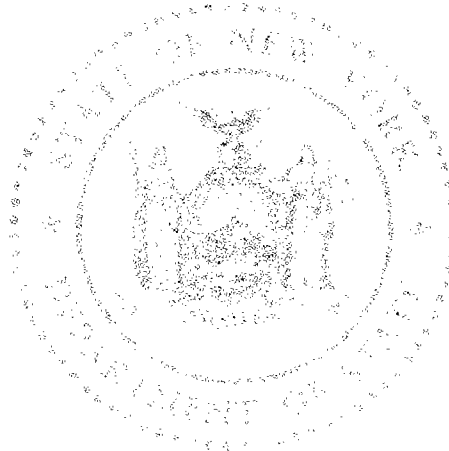
