## TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of September 15, 2009, by CITIGROUP GLOBAL MARKETS REALTY CORP., as Administrative Agent ("Agent").

### WITNESSETH:

WHEREAS, Agent and EDFINANCIAL SERVICES, LLC ("Borrower"), were parties to a Security Agreement dated as of September 25, 2006, pursuant to which Borrower granted a security interest to Agent in certain trademarks and trademark applications (the "Trademarks") as security for certain obligations owing by Borrower to Agent, including the Trademarks set forth on Schedule 1 hereto; and

(i) each Trademark listed on Schedule 1 annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and


(ii) all products and proceeds of the foregoing, including without limitation, any claim by Borrower against third parties for past, present or future (a) infringement or dilution of any Trademark, or (b) injury to the goodwill associated with any Trademark.

2. Agent hereby reassigns, grants and conveys to Borrower, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest in and to the Trademarks and the Trademark Rights.
