ASSIGNMENT OF TRADEMARKS AND COPYRIGHTS

WHEREAS, Stolle Machinery Company, LLC (“Assignor”), has adopted and used and is the owner of the registered trademarks and/or service marks set forth on Exhibit 1 attached hereto used primarily or exclusively in connection with the Didde Product Line, as well as various unregistered trademarks and/or service marks used in the business (if any) (the “Marks”), together with the goodwill and going concern value of the business in connection with which the Marks has been used (the “Goodwill”), the United States trademark registrations for the Marks, and any renewals that may be granted thereon, if any, set forth on Exhibit 1 attached hereto (the “Registrations” together with the Marks, the Goodwill and any of Assignor’s right, title and interest in and to any copyrights in any product or owners manuals or other written materials used exclusively and primarily in the Didde Product Line, the “Intellectual Property”);

WHEREAS, Assignee is desirous of acquiring from Assignor any and all of its right, title and interest in and to the Intellectual Property;

WHEREAS, this assignment (“Assignment”) is being executed and delivered in connection with that certain Asset Purchase Agreement by and between Assignor and Assignee, dated November 20, 2009 (the “Agreement”), whereby Assignor agreed to sell, transfer, assign, convey, set over and deliver to Assignee, all right, title and interest of Assignor, in and to all of the trademarks and copyrights used primarily or exclusively in connection with the Didde Product Line, which include the Intellectual Property; and

WHEREAS, capitalized terms used but not otherwise defined herein shall have the meanings given to them in the Agreement.

NOW, THEREFORE, in consideration of the mutual premises and promises contained herein, and in reliance upon the representations and warranties contained herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound, the Parties hereby agree as follows:

1. Assignor does hereby irrevocably sell, transfer, assign, convey, set over and deliver to Assignee and its successors and assigns all of Assignor’s right, title and interest in and to the Intellectual Property, and all rights, claims and privileges thereto, including all common law rights thereto, and including the right to sue for past infringements, to be held and enjoyed by Assignee, as well as all electronic and paper copies of documents related to the foregoing, all for Assignee’s own use and benefit and for the use and benefit of its subsidiaries, successors, assigns and legal representatives, for the full extent of the life of the Intellectual Property, to be used as fully and entirely as such rights would have been held and enjoyed by Assignor had this Assignment and sale not been made.
2. Assignor is the registered owner of the Marks (except with respect to any unregistered trademarks and/or service marks) and the holder of record title to the Registrations, and has full power to make this Assignment and Assignor agrees to execute such further assignments and related documents with respect to Assignor’s right, title and interest in

and to the Intellectual Property as Assignee shall reasonably request.

3. Assignor hereby waives all rights under the Visual Artists Rights Act of 1990 (17 U.S.C " 106A et. seq.) in connection with Assignee's use of the Intellectual Property in any manner.
4. This Assignment shall be governed by, and construed in accordance with the laws of the State of Ohio, without regard to its conflict of law principles, including the application of any applicable statutes of limitations and equitable principles and the availability of any remedies.
5. In the event of any conflict or other inconsistency between this Assignment and any other document, this Assignment shall be the controlling document.
