**AMENDED AND RESTATED  
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

THIS AMENDED AND RESTATED INTELLECTUAL PROPERTY SECURITY AGREEMENT (this “Agreement”) is entered into as of October 30, 2009, by and between WELLS FARGO BANK, NATIONAL ASSOCIATION, as administrative agent for itself and the other Lenders (as defined in the hereinafter defined Credit Agreement) to the extent and in the manner provided in the Credit Agreement (in such capacity, “Agent”), and PAPA MURPHY’S INTERNATIONAL, INC., a Delaware corporation (“Debtor”).

**RECITALS**

A. The Debtor and the Agent previously entered into the Intellectual Property Security Agreement dated as of June 30, 2004 (as amended and in effect immediately prior to the date hereof, the “Original IP Security Agreement”) pursuant to which the Debtor granted a security interest in its intellectual property as provided therein to secure the obligations under the Existing Credit Agreement (as defined in the Credit Agreement referred to below).

B. Pursuant to the terms of that certain Amended and Restated Credit Agreement of even date herewith among the Debtor, Papa Murphy’s Company Stores, Inc., a Washington corporation (“PM Company Stores”) and Papa Murphy’s Canada, Inc., a Delaware corporation (“PM Canada” together with the Debtor and PM Company Stores are collectively referred to herein as “Borrower”), Agent, and the other Lenders (as amended, modified and in effect, the “Credit Agreement”), the Lenders have agreed to provide Borrower certain loans (collectively, the “Loan”). All capitalized terms used and not otherwise defined herein shall have the respective meanings set forth in the Credit Agreement.

C. The Loan shall be evidenced by the Credit Agreement and certain promissory notes (individually, a “Note”, and collectively, the “Notes”), and secured by, in part, this Agreement.

**AGREEMENT**

NOW, THEREFORE, as a material inducement to Lenders and Agent to enter into the Credit Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Debtor and the Agent agree to amend and restate the Original IP Security Agreement in its entirety, as follows:

1. To secure the Obligations, Debtor grants and pledges to Agent, as administrative agent for itself and the other Secured Parties, a continuing security interest in all of Debtor’s right, title and interest in, to and under the following, whether now owned or hereafter acquired (collectively, the “Intellectual Property Collateral”): its intellectual property (including without limitation those trademarks listed on Schedule A hereto, but excluding any rights of Debtor as a licensee of intellectual property to the extent the grant of a security interest in or assignment

thereof is not permitted under the license agreement or other governing document), and including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), payable to or received or receivable by Debtor under, or in connection with the foregoing, the right to sue for past, present and future infringements (which right Agent shall not exercise unless an Event of Default shall have occurred and be continuing), and all rights corresponding thereto throughout the world. The Debtor authorizes the Agent to record this Agreement (including as amended, modified or supplemented from time to time pursuant to Section 2) with the United States Patent and Trademark Office and the United States Copyright Office, as appropriate.

2. Concurrently with the delivery of each Compliance Certificate required to be delivered pursuant to Section 6.01(d) of the Credit Agreement, the Debtor shall provide the Agent an updated Schedule A to this Agreement in form and substance reasonably satisfactory to the Agent listing all Intellectual Property Collateral of the Debtor at such time, including any Intellectual Property Collateral acquired by the Debtor during the Fiscal Quarter covered by such Compliance Certificate, together with any other information reasonably requested by the Agent. The Debtor authorizes the Agent to modify this Agreement without the necessity of the Debtor's further approval or signature by amending Schedule A to include any such new Intellectual Property Collateral acquired by the Debtor after the date hereof.

3. All rights of Agent hereunder shall inure to the benefit of its successors and assigns; and all obligations of Debtor shall bind its heirs, executors, administrators, successors and assigns.

4. Each right, power and remedy of Agent provided for herein or in the Credit Agreement or any of the Loan Documents, or now or hereafter existing at law or in equity shall be cumulative and concurrent and shall be in addition to every right, power or remedy provided for herein and the exercise by Agent of any one or more of the rights, powers or remedies provided for in this Agreement, the Credit Agreement or any of the other Loan Documents, or now or hereafter existing at law or in equity, shall not preclude the simultaneous or later exercise by any person, including Agent, of any or all other rights, powers or remedies.

5. This Agreement shall terminate upon the payment and performance in full in cash of all of the Obligations.

6. DEBTOR AND AGENT REPRESENT, WARRANT, AND ACKNOWLEDGE TO EACH OTHER THAT THIS AGREEMENT BEARS A REASONABLE RELATIONSHIP TO THE STATE OF NEW YORK. THIS AGREEMENT SHALL BE GOVERNED BY AND CONSTRUED AND ENFORCED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK, AND THE APPLICABLE LAWS OF THE UNITED STATES.


7. This Agreement amends, restates, supersedes, and replaces in its entirety the Original IP Security Agreement. The security interest granted by the Debtor to the Agent in the Intellectual Property Collateral under the Original IP Security Agreement continues without interruption under this Agreement but shall secure the Obligations and such security interest is hereby ratified and confirmed in all respects. As of the Closing Date, the rights and obligations

of the parties under the Original IP Security Agreement shall be subsumed within and governed by this Agreement.

IN WITNESS WHEREOF, the parties have caused this Agreement to be duly executed by its officers thereunto duly authorized as of the first date written above.



