TRADEMARK ASSIGNMENT

This Trademark Assignment, dated December 7, 2009, is made between United Site Services Northeast, Inc., a Massachusetts corporation ("Assignor"), and United Site Services, Inc., a Massachusetts corporation ("Assignee") (collectively referred to as the "Parties").

WHEREAS, Assignor owns the registration on the Principal Register of the United States Patent and Trademark Office listed on the Schedule attached hereto and all goodwill associated therewith (collectively the "Marks"); and

WHEREAS, Assignor desires to assign to Assignee and Assignee desires to accept the assignment of all rights in the Marks.

NOW THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, the Parties agree as follows:

Assignor does hereby contribute, sell, convey, transfer, assign and deliver to Assignee, its successors and assigns, and Assignee purchases and accepts from Assignor, all of Assignor's right, title and interest in and to the Marks throughout the world, including all registrations and applications thereof and all goodwill pertaining thereto, the right to conduct business under the Marks, including the right to license others under the Marks, the portion of the business of Assignor to which any intent-to-use application pertains, and all rights to sue, counterclaim and collect damages and payments for claims of past, present and future infringements, unfair competition or misappropriations thereof, and all income, royalties, damages and payments now or hereafter due or payable with respect to the Marks.

Assignor hereby authorizes the United States Patent and Trademark Office and/or the appropriate empowered officials in relevant jurisdictions outside the United States to transfer all registrations for the Marks to Assignee as assignee of the entire right, title and interest therein or otherwise as Assignee may direct, in accordance with this instrument of assignment.


Assignor will take, or cause to be taken, all such other and further action as may reasonably be required by Assignee in order to effect the assignment contemplated hereby.

Assignor further covenants and agrees that Assignor will at any time upon request of Assignee, and at Assignee's expense, communicate to Assignee any facts relating to the Marks known to Assignor, and that Assignor will testify upon the request of Assignee as to the same in any proceeding in the United States Patent and Trademark Office or in connection with any litigation involving the Marks.


