CONFIRMATION ASSIGNMENT OF REGISTERED TRADEMARK

WHEREAS, Newport, Corporation, a Nevada corporation (“Assignor”), having its principal place of business at 1791 Deere Avenue, Irvine, California 92606, is the owner of the mark MONSOON in International Class 009 in commerce having been registered on December 9, 2003 with the United States Patent and Trademark Office, assigned Registration No. 2,792,943, and

WHEREAS, Assignor and the Assignee (defined below) are parties to that certain Newport Asset Purchase Agreement dated June 2, 2009 (the “Asset Purchase Agreement”), pursuant to which Assignor sold and transferred to the Assignee Effective July 4, 2009 certain assets of Newport, including the mark MONSOON;

NOW, THEREFORE, on or about July 4, 2009 for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor assigned to Assignee all right, title and interest in and to the trademark MONSOON, together with the accompanying goodwill and that portion of the business represented and symbolized by such trademark, the application for such trademark, all related common law rights, the right to register, renew, protect and defend such trademark and the right to sue for past infringements of such trademark. Assignor agrees to cooperate with Assignee to record this Assignment in the United States Patent and Trademark Office and to extend such other cooperation and perform such other acts as may be necessary or appropriate, in the opinion of Assignee, to convey, establish, evidence, maintain, defend and enforce Assignee’s rights in the trademark MONSOON; and Assignor hereby irrevocably appoints Assignee and any of its officers as Assignor’s attorney in fact to undertake such acts in Assignor’s name.




