**AFFIDAVIT REGARDING ERRONEOUS ASSIGNMENT INFORMATION**


I, Valerie Pochron, declare as follows:

1. I am legal counsel for Doctor's Associates Inc.
2. On August 24, 2004, the above-referenced trademark registration was assigned from Ellis Coffee Company to Royal Cup, Inc., which assignment was recorded September 1, 2004 at Reel 2927, Frame 0809 (2 pages).
2. On August 10, 2005, the registration was assigned from Royal Cup, Inc. to Doctor's Associates Inc. , which assignment was recorded October 7, 2005 at Reel 3172, Frame 0197 (3 pages).
3. On June 22, 2007, the registration was erroneously conveyed as a security interest by Ellis Coffee Company to The CIT Group/Commercial Services, Inc., which conveyance was recorded July 2, 2007 at Reel 3572, Frame 0925 (10 pages).
4. On July 22, 2008, the registration was erroneously assigned in its entirety from The CIT Group/Commercial Services, Inc. to Wells Fargo Bank, NA, which assignment was recorded August 11, 2008 at Reel 3836, Frame 0807 (4 pages).

5. The current owner of the mark should be listed as Doctor's Associates Inc. as the security interest to The CIT Group/Commercial Services, Inc. and subsequent assignment to Wells Fargo Bank, NA were erroneous since Ellis Coffee Company was no longer the owner of the registration at the time of conveyance.

6. The last correct assignee, Doctor's Associates Inc., has been and continues to be the owner of the registration at issue.
