**WITNESSETH:**



NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, BOW hereby releases, discharges, quit claims and relinquishes unto the Assignor any and all right, title and interest in and to the Marks, and more particularly, (i) the security interest in the trademarks, trademark registrations and trademark applications as set forth on Schedule A hereto, (ii) all Proceeds (as such term is defined in the Security Agreement) and products of the Marks and (iii) the goodwill of the business symbolized by the Marks, and


