Security Agreement

Trademarks

WHEREAS, SILBERLINE MANUFACTURING CO., INC., an Indiana corporation (herein referred to as the “**Company**”), has adopted the trademarks and service marks listed in Schedule A attached hereto and made a part hereof, which trademarks and service marks are registered or pending registration in the United States Patent and Trademark Office, and has adopted the common law trademarks, service marks and trade names listed in Schedule B attached hereto and made a part hereof (collectively, the “**Trademarks**”);

WHEREAS, the Company is obligated to CITIZENS BANK OF PENNSYLVANIA, a Pennsylvania banking institution (herein referred to as the “**Bank**”), and has entered into an Intellectual Property Security Agreement dated the date hereof (the “**IP Agreement**”) in favor of the Bank;

WHEREAS, pursuant to the IP Agreement, the Company has granted to the Bank a security interest in, and mortgage on, all right, title and interest of the Company in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof, all as more fully described in the IP Agreement (the “**Collateral**”), to secure the payment, performance and observance of the Obligations, as defined in the IP Agreement; and

WHEREAS, this Agreement does not supersede, amend, modify, revise or limit the IP Agreement, and is intended to supplement the IP Agreement and evidence and perfect the Bank’s security interest in the Collateral.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Company does hereby further grant to the Bank a security interest in, and mortgage on, the Collateral to secure the prompt payment, performance and observance of the Obligations.

The Company does hereby further acknowledge and affirm that the rights and remedies of the Bank with respect to the assignment of, security interest in and mortgage on the Collateral made and granted hereby are more fully set forth in the IP Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.
