## RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE dated as of December 1, 2009 (this "Release") is made by Agent (as defined below) (the "Secured Party") pursuant to (a) the Revolving Credit and Term Loan Agreement dated as of May 31, 2005 (as amended, restated or otherwise modified from time to time, the "Credit Agreement"), among Alfred Publishing Co., Inc., a New York corporation, Alfred Music Group Inc. (f/k/a Warner Bros. Publications U.S. Inc.), CPP/Belwin, Inc., the financial institutions signatory thereto (the "Lenders") and Comerica Bank, as agent for the Lenders (in such capacity, "Agent") and (b) the Trademark Security Agreement ("Security Agreement") dated as of May 31, 2005 and recorded on June 24, 2005 in the records of the United States Patent and Trademark Office at Trademark Reel 003110, Frame 0178, between Warner Bros. Publications U.S. Inc. (n/k/a Alfred Music Group Inc.), a New York corporation, and CPP/Belwin, Inc., a Delaware corporation (together, the "Debtors"), and Secured Party.


WHEREAS, pursuant to the above-referenced Security Agreement, Debtors granted to the Secured Party a security interest in Debtors' trademarks, including those listed on **Schedule 1.1** attached hereto (the "Trademarks").

WHEREAS, in connection with the payoff of the loans under the Credit Agreement, the Secured Party wishes to: (i) release all of its security interest covering the Trademarks; (ii) restore all right, title and interest in and to the Trademarks to Debtors; and (iii) dissolve any and all liens and encumbrances respecting the Trademarks under the Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby release its security interest in the Trademarks, and discharges, quit claims and relinquishes unto Debtors (in each case without recourse and without any representation or warranty) any and all right, title and interest it has in and to the Trademarks under the Security Agreement.
