LICENSE AGREEMENT

(Contrat de licence de marque)

BY AND AMONG

BACCARAT S.A.
AS PROPRIETOR

AND

SCBA, L.L.C.
AS LICENSEE

Dated as of

BETWEEN :

BACCARAT S.A., a company organized under the laws of the French Republic as a *société anonyme*, having its registered office at rue des cristalleries, 54120 Baccarat (France), registered with the Trade and Companies Registry of Nancy under number 760 800 060,

(hereinafter referred to as the “**Proprietor**”),

ON THE FIRST PART,

AND

SCBA, L.L.C., a company organized under the laws of Delaware, United States of America, having its registered office at Corporation Trust Center, 1209 Orange Street, Wilmington, Delaware, U.S.A.,

(hereinafter, together with its successors in interest, referred to as the “**Licensee**”),

ON THE SECOND PART,

(hereinafter collectively referred to as the “**Parties**” and individually as a “**Party**”).

WHEREAS :

- A.** The Proprietor is a company that historically manufactures and markets high quality crystal products under the prestigious brand name "Baccarat" (the "Baccarat Brand"). During recent decades, the Proprietor has diversified its activities and has developed inter alia jewellery, gift and lighting products, as well as lounge and restaurant activities which are sold or operated, as the case may be, under the Baccarat Brand and the brand names "B", "Cristal Room", "B-Bar by Baccarat" and "B Bar" (together with the Baccarat Brand, the "Brand").
- B.** The Licensee, an Affiliate of Starwood Capital Group Global, L.L.C. among its other activities, currently, directly or indirectly through Affiliates, owns and/or operates a significant number of luxury hotels and resorts throughout the world under, but not limited to, the brand names "Crillon", "Westin", "Concorde" or "Meridien". The Licensee, and/or its Affiliates, is further the founding partner of Starwood Hotels & Resorts Worldwide, one of the world's largest full service hotel and resort companies. In this respect, the Licensee is recognized as one the major participants in the ownership and/or operation of luxury hotels worldwide.
- C.** In the framework of its global strategy regarding the continued development of its luxury hotels business, the Licensee seeks to innovate constantly and to ensure that its hotels are universally recognized for their quality, service and high brand standards. In this context, the Licensee has approached the Proprietor in order to build or develop, own and/or operate luxury hotels and luxury resorts (together, "Luxury Hotels" as defined herein) as well luxury rental and for-sale residences ("Luxury Residences" as defined herebelow) under the Baccarat Brand, based on the fact that this could constitute an opportunity both for the Licensee and for the Proprietor. The Luxury Hotels and Luxury Residences operated under the Baccarat Brand would benefit from the high quality and luxury image of the Brand, while allowing the Proprietor to further diversify its activities, globalize the reputation of the Brand and contribute to the strategic business development of the Proprietor.
- D.** After having considered the feasibility of the proposed agreement, the Proprietor has decided to proceed with its implementation. Therefore, in consideration of the mutual undertakings and commitments set forth herein, the Parties have decided to enter into this Agreement (as this term is defined herebelow), the purpose of which is to define the terms and conditions under which the Licensee shall be authorized to open and/or operate Luxury Hotels under the Brand or have Affiliates (as this term is defined herebelow) own and/or operate such Luxury Hotels.

NOW, THEREFORE IT HAS BEEN AGREED AS FOLLOWS:

Article 1. DEFINITIONS

The following terms and expressions used in the Agreement shall have the following meanings :

ADVISORY COMMITTEE : means the committee composed of (i) a representative of the majority shareholder of the Proprietor who is a member of its Board of Directors, (ii) the Proprietor's CEO (or its lead creative executive), and (iii) one of the Proprietor's independent members of its Board of Directors.

AGGREGATE FOOD AND BEVERAGE REVENUES : [REDACTED]

AGGREGATE ROOMS REVENUES : [REDACTED]

AFFILIATE : means with respect to any Party, any entity controlled, or co-controlled, by, controlling or under common control with such Party. This term also means, with respect to the Licensee, (i) any entity of which Barry Sternlicht is CEO, Co-CEO, Chairman or Co-Chairman of the entity or the Board of the entity, provided that such positions shall have the power to implement this Agreement when such entity is granted a sub-license hereunder and (ii) any entity managed by the Licensee and any entity controlled by, controlling or under common control with such entity managed by the Licensee. As used herein, the term (i) "control" means to possess, directly or indirectly, the power to direct the management or policies of such entity, whether through ownership of voting securities or shares, or by contract relating to voting rights or corporate governance or by management agreement, and (ii) "co-control" means the power to co-direct the management of such entity (including the power to co-implement this Agreement when such entity is granted a sub-license hereunder. Without limiting the generality of the foregoing, the ownership of more than fifty percent (50%) of the voting shares (or voting interests) in any such entity shall be deemed "control" of such entity and the ownership of 50% of the voting shares (or voting interests) in any such entity together with the power to co-direct the management of such entity shall be deemed co-control of such entity.

With respect to the Licensee, an Affiliate shall be used under this Agreement only to own and/or operate one or several Licensed Hotels, including the case in which an Affiliate is a sublicensee of the Licensee in the conditions set forth in Article 12.1 of this Agreement.

AGREEMENT : means the present license agreement together with the exhibits hereto, as it or they may be amended, restated or supplemented or otherwise modified in the future;

BACCARAT BRAND : means the Baccarat trademark as defined in the preamble of this Agreement and the details of which (including a list of registrations) are listed in Exhibit 1 of this Agreement;

BACCARAT BRAND VALUES : means the values of the Baccarat Brand as described in Exhibit 3 of this Agreement;

BRAND : means the “Baccarat”, “B”, “Cristal Room”, “B-Bar by Baccarat” and “B Bar” trademarks as defined in the preamble of this Agreement, and the details of which (including list of registrations) are listed in Exhibit 1 of this Agreement;

BUSINESS DAY : means a day (other than a Saturday or Sunday) on which banks are open for general business in Paris and New York;

DURATION : bears the meaning conferred in Article 8 of this Agreement;

EXPERT : bears the meaning conferred in Article 7 of this Agreement;

GROSS UNIT SALES : [REDACTED]

GUIDELINES : bears the meaning conferred in Article 3.1 of this Agreement;

LICENSED HOTEL NAME : means the trade name of the License Hotels including the Baccarat Brand in association with any other name or designation;

INSPECTION PERIOD : bears the meaning conferred in Article 7 of this Agreement;

LICENSE : bears the meaning conferred in Article 2 of this Agreement;

LICENSED HOTELS : bears the meaning conferred in Article 2 of this Agreement;

LICENSEE CALCULATION : [REDACTED]

LICENSEE RESPONSE : bears the meaning conferred in Article 7 of this Agreement;

LUXURY HOTELS : means any five (5) star hotel, resort or equivalent (which includes facilities located therein including, but not limited to, restaurants, spas and health clubs, for use, the case of spas and health clubs by hotel guests) as provided by applicable international standards or such other regulations of any local country in which Licensed Hotels are located;

LUXURY RESIDENCES : means units that may be offered for private ownership on the grounds of, contiguous to, or otherwise a part of, any Licensed

Hotel property (which includes facilities located therein including, but not limited to, restaurants, spas and health clubs, for use, the case of spas and health clubs by hotel guests), provided that any Luxury Residence shall remain associated with the operation of a Luxury Hotel during all the term of the License as to such Licensed Hotel;

MINIMUM PURCHASE OBLIGATION

: bears the meaning conferred in Article 15 of this Agreement;

OUTLETS : bears the meaning conferred in Article 2.3 of this Agreement;

**PROPRIETOR
CALCULATION** : [REDACTED]

RETAIL STORES : bears the meaning conferred in Article 3.6 of this Agreement;

ROYALTIES : [REDACTED]

SECONDARY BRANDS : means the “B”, “Cristal Room”, “B-Bar by Baccarat” and “B Bar” trademarks as referred to in the preamble of this Agreement and the detail of which (including list of registrations) are listed in Exhibit 1 of this Agreement;

TERRITORY : means all the territories in which the Brand has been registered or a registration application is pending, the details of which are listed in Exhibit 1 of this Agreement.

QUALIFIED HOTEL OPERATOR

: shall mean a person or entity that has the skill, acknowledged experience in the luxury hotel industry, professional resources and financial ability to (i) perform the duties and obligations of Licensee under this License Agreement; (ii) perform the duties and obligations of Licensee under any management or other agreement then in effect for the management or operation of a Licensed Hotel; and (iii) continue to manage or operate such Licensed Hotels in accordance with the Guidelines.

Article 2. GRANT OF LICENSE

2.1. The Proprietor hereby grants the Licensee an exclusive license to use and to sub-license only to its Affiliates (i) the use of the Baccarat Brand to name Luxury Hotels and Luxury Residences in the Territory and (ii) the use of the Baccarat Brand to (a) open and/or operate Luxury Hotels and Luxury Residences in the Territory (the “Licensed Hotels”) and (b) to operate any health club or spa facilities located within the Licensed Hotel premises (solely for hotel guests or those individuals who live in, own or who are guests at, Luxury Residences), subject to the provisions of this Agreement (the “License”).

2.2. The License shall also confer the right for the Licensee to use the Baccarat Brand on the frontage, and any other signage, of the Licensed Hotels (and more generally anywhere on the property), and *inter alia* the right for the Licensee to use the Brand on the commercial and/or corporate documentation and websites of the Licensed Hotels, in advertising in all media (subject to the consultation with and approval, not to be unreasonably withheld or delayed, from the task force as described in Article 11 or otherwise consistent with the Guidelines), with respect to all management activities and services (and signage related thereto) offered at, or with respect to, the Licensed Hotels.

In addition, the Licensee shall be authorized to associate the Baccarat Brand with the name of each Licensed Hotel and to use the Brand as domain names in connection with the operation of the Licensed Hotels, subject to such domain names be registered in the name of the Proprietor as provided in Article 5.6 below. It is expressly provided that the Licensee shall not be entitled to use the Baccarat Brand on any goods or operating equipment as, *inter alia*, chinaware, tableware or decorative items that have not been expressly sold through the Proprietor or any of its Affiliates to the Licensee or any of its Affiliates. Proprietor shall provide such goods at the applicable local wholesale price (according to the published wholesale price list).

2.3. The License shall also confer the right for the Licensee to operate in the Licensed Hotels premises any lounge, bar, café or restaurant outlets under the Brand (when Branded, the “**Outlets**” and when not Branded, the “outlets”) and to use the Brand on any consumable items in such Outlets (such as textiles and napkins, for example), subject to the provisions set forth in Article 3.1 below. Licensee shall have the right to operate, or engage third parties to operate, other outlets within the Licensed Hotels [REDACTED] ;

In addition, in case the Licensee at its option, would contemplate the operation in the Licensed Hotels of the Outlets under the Brand, it shall fit out such Outlets with Baccarat Brand products purchased either from the Proprietor or its Affiliates in the conditions set forth in Article 15 hereof, at the local wholesale price (according to the published wholesale price list).

2.4. The Proprietor acknowledges and agrees that the Licensee shall be entitled to operate and/or to develop, or procure the development and/or operation of any new hotel under the Baccarat Brand so that it becomes a Licensed Hotel, provided such new hotel is a Luxury Hotel and meets the requirements set forth in Article 3 below.

2.5. The Licensee will notify, as soon as reasonably possible, the Proprietor as to the details of any new Luxury Hotels it intends to include as Licensed Hotels.

The specific locations of any new Luxury Hotel intended to become a Licensed Hotel that the Licensee believes in good faith to be consistent with the Guidelines and the Brand image shall be submitted first to (i) the Advisory Committee for an opinion as to the consistency of the specific location with the Guidelines and the Brand image (such committee and its members acting reasonably and without unreasonable delay) and then (ii) to the Proprietor’s Board of Directors for its prior express approval, such approval not to be unreasonably withheld or delayed. Such Luxury Hotels will be governed by the terms of this Agreement.

The first Luxury Hotels locations that are contemplated to become Licensed Hotels are listed in Exhibit 4 hereto.

- 2.6. The Licensee agrees and acknowledges that the License is limited to the Licensed Hotels only and shall not confer any right to use the Brand in any context other than in the hotel industry. For the avoidance of doubt, it is expressly acknowledged by the Parties that the Licensed Hotels must be owned and/or operated by the Licensee or any of its Affiliates.

For the purpose of this Article, "operation" shall mean the leasing of a Luxury Hotel or of its goodwill (*fonds de commerce*) or the entry into a management agreement relating to a Luxury Hotel and/or Luxury Residences.

- 2.7. The License shall also confer the right for the Licensee and for any of its Affiliate to use the Licensed Hotel Name, as well as the "B" trademark, (i) on any consumable items including, but not limited to, soaps, items which are included in amenities programs, textiles and the like; and (ii) on any health club or spa type of facility located within the Licensed Hotel premises. Consent from the Proprietor, shall be required in the case of the use of the "B" trademark, but no such consent shall be needed with respect to the use of the "B" trademark in association with the Licensed Hotel Name.

Article 3. PARTICULAR OBLIGATIONS OF THE LICENSEE/USE OF THE BRAND

- 3.1. The Licensee acknowledges and agrees that the Proprietor has an overriding interest in maintaining the prestige and reputation of the Brand and the high quality of the Licensed Hotels. In this respect the Licensee undertakes for each Licensed Hotel, prior to final decision by the Licensee on the interior design of such Licensed Hotel, to regularly consult with task force or designee of Proprietor on matters of design, image and Brand use in connection with aesthetic and fitting out to ensure at any time the consistency and maintenance of the Baccarat Brand Values (as defined below) as to each such Licensed Hotel. For that purpose, the task force or designee of the Proprietor and the Licensee shall regularly meet and consult each other, (the task force and/or designee of the Proprietor and the Licensee acting reasonably and without delay) to provide input and comments for each Licensed Hotel, prior to final decision by the Licensee on the interior design of such Licensed Hotel. Licensee, shall develop, operate and maintain each Licensed Hotel at to a standard consistent with Luxury Hotels (as defined herein) which, for example, include hotels operated by The Four Seasons, Peninsula Hotels, Shangri-La Hotels and/or the Mandarin Oriental Hotel Group as well as in a manner consistent with the Baccarat status and the Baccarat Brand Values as described in Exhibit 3 of this Agreement (such standard to constitute and be defined as the "Guidelines").

Without limiting the generality of the foregoing provisions, the consultation with task force or designee of the Proprietor shall take place following the designation of the specific location of any new Luxury Hotel project being submitted to the Proprietor's Board of Directors for approval as provided in Article 2 above. Thereafter the task force (or designee of the Proprietor) will meet, as necessary, as to each Licensed Hotel, during the development process, and prior to opening, of any Licensed Hotel.

- 3.2. The Licensee undertakes to allow representatives of the Proprietor (including any designated consultant) to access and inspect the Licensed Hotels at any time, during the

hours of 9 AM to 4:30 PM, during the term of the License as to each Licensed Hotel, upon reasonable prior notice, in order for such representatives to verify that the Licensed Hotels constantly remain Luxury Hotels and to ensure the consistency and maintenance of the Brand reputation.

- 3.3. The Licensee undertakes to represent the Brand on all printed materials and signages strictly in accordance with the form and the graphic chart as provided in Exhibit 5 of this Agreement.
- 3.4. The use of the Brand by the Licensee shall be made in accordance with applicable law and the provisions of this Agreement in order to preserve the rights of the Proprietor over the Brand and shall be used only in connection with Licensed Hotels at a finish, design and operations level consistent with the Guidelines and the status of the Baccarat Brand as premiere luxury brand. In any case, the Licensee shall use the Brands in such a way that this use shall not harm the value, the renown and the goodwill associated with the Brands.

The Licensee shall also ensure at any time throughout the Duration a high level of maintenance and servicing of the Licensed Hotels consistent with the Brand reputation, provided that maintenance and servicing consistent with the Guidelines, and with Luxury Hotels in the specific Territory, shall be deemed in compliance with this provision.

- 3.5. [REDACTED] For purposes of this Article 3.5, Article 4, and the definition of "Affiliate," excluding only subpart (iv) of this Article 3.5 as regards the definition of Affiliate) the requirement to "own, and/or operate and/or commit" shall be met by any one of the following : any Licensed Hotel either being (i) acquired, (ii) managed, (iii) controlled, (iv) committed to, or (v) the subject of an executed agreement (management, or otherwise) by the Licensee or any Affiliate.

Any dispute between the Parties as to the consistency of any sites with the Guidelines shall be submitted to arbitration in the conditions set forth in Article 21.2 hereof.

- 3.6. In case the Licensee would contemplate the operation in any Licensed Hotel premises of a crystal or similar product retail store (the "Retail Store"), it will grant to the Proprietor a right of first refusal to operate the Retail Store.

For this purpose, the Licensee shall notify to the Proprietor all the contemplated conditions of operation of the Retail Store (including but not limited to specific location, surface, terms and conditions of the lease or management agreement).

Within sixty (60) days, following receipt of such notice, the Proprietor shall notify of its intention to exercise or not its first refusal right. Failure by the Proprietor to notify its intention within such period of 60 days shall be deemed to be a refusal by the Proprietor to operate the Retail Store and the Licensee shall be free to operate the Retail Store, through any third party, in its absolute discretion, provided that in no event shall Licensee, in a Licensed Hotel, permit the operation of any retail crystal store which sells crystal products which compete with the Proprietor's crystal products (including, but not limited to, Swarovski, Lalique or Daum).

- 3.7. In case of expiry or termination (under Article 9 below) of this Agreement as to a Licensed Hotel, the Licensee, or any of its Affiliates, shall within 90 days following the expiry or termination of the Agreement with respect to such Licensed Hotel discontinue the use of the Brand at such Licensed Hotel and destroy all items bearing the Brand in such Licensed Hotel, including any advertising and promotional materials. In case the Licensee or any of its Affiliates would fail to comply with this obligation, it will be liable for the payment of a penalty amounting to EUR 2000 per day of arrears, which penalty will accrue as of the 30th day following the termination or expiry of the Agreement.

Article 4. EXCLUSIVITY

This License is an exclusive License to use the Brand in the hotel industry and accordingly, the Proprietor undertakes not to enter into any other agreement whatsoever the purpose of which would be to grant a direct or indirect license over the Brand in order to use the Brand in the hotel industry without the written prior consent of the Licensee. Nothing herein shall be construed to prevent the Proprietor from using or licensing the Secondary Brands, for use outside the hotel industry in any territory provided however that the operation of any outlet under the Secondary Brands by the Proprietor or any licensee be at all times associated with the operation of a retail store for the resale of Baccarat Brand products.

More generally, the Proprietor expressly agrees that the Brand shall not be used in the hotel industry by itself or its Affiliates or any one else but by the Licensee or its Affiliates throughout the Duration, and any renewal subsequent periods.

Article 5. NO WARRANTY/TITLE / EXTENSION OF THE TERRITORY

- 5.1. The License is granted with no warranties attached except for the specific warranties made by the Proprietor in Article 10 herebelow.
- 5.2. The Licensee acknowledges that the Proprietor is the exclusive owner of the Brands and that it has no right, title or interest in the Brands other than those which are granted to it under the Agreement.
- 5.3. The Licensee shall not file as a trademark or domain name in its own name any designation or logo identical or similar to, or derived from, or which may create a risk of confusion with the Brands for any product or service whatsoever in the Territory or in any country where the registration of the Brands has not yet been carried out or applied for by the Proprietor.
- 5.4. When the registration of one or more of the Brands shall be necessary for the operation of the Licensed Hotels, the Licensee may request the Proprietor to file an application for registration of such Brands in any country of its choice which is not listed in Exhibit 1. Within locally applicable regulatory limits, the Proprietor shall register in its own name the Brands requested by the Licensee. All countries where the registrations have taken place under the conditions provided for above shall be considered as part of the Territory.
- 5.5. The Licensee may request the Proprietor to, and the Proprietor shall, (i) register as a trademark in any country any name or graphic bearing the term "Baccarat" or any name,

logo or graphic derived from the Brands when the registration of such distinctive signs as a trademark shall be necessary to the operation of the Licensed Hotels and (ii) to undertake any extension of the products and/or services for any Brand in the Territory when such extension shall be necessary to the operation of the Licensed Hotels.

5.6. The Licensee may also request the Proprietor to undertake any registration of domain names bearing the Brand in any extension which Licensee may designate when such registration shall be necessary to the operation of the Licensed Hotels. Such registrations shall be undertaken solely in the name of the Proprietor.

The Licensee may also request, at its sole expense, the Proprietor to set up a link from the Proprietor's website to the Licensee's website.

5.7. The costs, expenses and fees connected with the registrations, after the date hereof, referred to in Articles 5.4 and 5.5 and 5.6 above (particularly the costs for research of prior use, responses to administrative objections, publication and/or registration fees) until issuance of the trademarks or domain names for any Brand, shall be borne by the Licensee.

Article 6. ROYALTIES

Article 7. BOOK AND RECORDS/AUDIT

For each Licensed Hotel, the Licensee shall keep accurate and complete records of billings, revenues received and all other records (including the identity of and number of customers) reasonably necessary to substantiate all payments of the Royalties to be made to the Proprietor pursuant to this Agreement.

All such records and accountings with respect thereto prepared during the past one (1) year will be available for inspection and audit by the Proprietor or its representatives during a sixty (60) day-period following each anniversary of this Agreement (the "Inspection Period"). It is expressly acknowledged, however, that the Proprietor shall not be authorized to make copies of such documents. Any such inspection by the Proprietor shall not last more than ten (10) Business Days.

In order to exercise the rights set forth in this Article 7, the Proprietor shall give the Licensee five (5) Business Days advance written notice of any such audit. Such audit shall not unreasonably interfere with the day-to-day operation of any of the Licensed Hotels, and shall be accomplished at the Proprietor's expense.

All financial information, records and accounts disclosed to the Proprietor or its representatives for the purpose hereof will be deemed to be confidential information and the Proprietor and its Affiliates expressly undertakes to maintain such confidentiality.

Article 8. DURATION OF THE AGREEMENT

The License is granted for a duration of twenty (20) years from the date of this Agreement (the "Duration") provided however that (i) subject to the renewal rights set forth below, the License shall continue, under the terms and conditions hereof, as to each Licensed Hotel, to a date which is twenty-five (25) years from the date such Licensed Hotel is opened to the general public as a Licensed Hotel, to provide the Licensee a minimum term of 25 years as to each such Licensed Hotel and (ii) as long as the terms and conditions of the License shall remain in full force as to any Licensed Hotel, the Licensee (as regards all Licensed Hotels which are open to the general public as a Licensed Hotel) shall continue to be bound by any and all obligations hereof. Including, but not limited to, the payment of the Royalties which are due in the conditions set forth in Article 6 hereabove.

At the end of the Duration, if the Proprietor, at its own discretion, intends to continue the License, the Licensee shall have an option to renew this Agreement for a period of ten (10) years upon such terms and conditions to be mutually agreed upon by the Parties. The Proprietor shall notify in writing its intent to continue the License at least one year before the expiration of the Duration. In such case, if the Licensee does not exercise in writing its option to renew the Agreement or the Parties fail to reach an agreement upon the terms and conditions of such renewal within a period of [6] months following receipt of the Proprietor's written notice, this Agreement shall expire at the end of the Duration.

For the avoidance of doubt, it is expressly acknowledged that upon expiration of the Duration, or the renewal period as set forth in the precedent paragraph or upon an early termination of this Agreement in the conditions set forth in section 12.1 hereof, (i) the Licensee shall not be authorized to open any new Licensed Hotels, unless such Licensed Hotels have already been approved by the Board of Directors of Proprietor, in which case such Licensed Hotels shall, subject to the renewal rights set forth below, be subject to a twenty-five (25) year term License from the date of opening to the general public as a Licensed Hotel; (ii) the Proprietor shall be free to use or to enter into any agreement with any third party to license the Brand in the hotel industry, subject to reasonable radius restrictions set forth in applicable agreements, regarding any Licensed Hotel, as disclosed to the Proprietor as soon as practicable and not later than 20 days prior to the execution of such agreements and (iii) the terms and conditions of the License shall remain in full force and effect as to each then existing Licensed Hotel. The term of this License as to each Licensed Hotel (i.e. twenty-five years) shall automatically renew for subsequent periods of (10) years each, unless any Party notifies in writing its intent to terminate the License as to each Licensed Hotel at least one (1) year before the end of the given period.

Article 9. EARLY TERMINATION

9.1. The Proprietor shall be authorized or shall cause the Licensee to early terminate this Agreement with respect to a particular Licensed Hotel and not all Licensed Hotels except in the cases of Articles 9.1.1, (subject to 9.1.1(i) and (ii)), 9.1.2 and 9.1.3, for which Proprietor can terminate this Agreement in its entirety (i.e., for all Licensed Hotels) if:

- 9.1.1 the Licensee fails to make payment of the Royalties due pursuant to and in the conditions set forth in Article 6 hereabove, unless (i) there exists a bona fide dispute between the Parties regarding the method of calculation of such payment in the conditions set forth in Article 7 hereabove or (ii) such default of payment of

the Royalties (or failure to pay such Royalties) by the Licensee results from, arises out of, or is related to, a default of payment of the Royalties (or failure to pay such Royalties) by any of its Affiliate which is a sublicensee of the Licensee, being provided that in such case the provisions of subpart (ii) of Article 12.1, as well as the paragraph after 12.1(ii) commencing with the words "for the avoidance of doubt" shall apply in their entirety;

- 9.1.2 both the Licensee and its Affiliates, in aggregate, fail to own and/or operate and/or commit one Licensed Hotel within a period of thirty six (36) months commencing on the date hereof;
- 9.1.3 both the Licensee and its Affiliates, in aggregate, cease at any time for a consecutive period of thirty six (36) months to substantially use the Baccarat Brand;
- 9.1.4 the Licensee or any of its Affiliates is in substantial breach of any material obligation under this Agreement. For purpose of this Article 9.1.4, the following shall be considered, inter alia, as a material obligation : the obligation to ensure a high level of maintenance and servicing for any Licensed Hotel, provided that such maintenance and servicing consistent with the Guidelines, and with Luxury Hotels generally or in the specific Territory, shall be deemed not to be a breach of this provision;
- 9.1.5 one of the Licensed Hotels ceases to be a Luxury Hotel, or one of the Licensed Hotels ceases to be owned and/or operated by the Licensee or any of its Affiliates, or the Licensee ceases to control or to co-control any Affiliate which operates one of the Licensed Hotel unless Barry Sternlicht is either the CEO, Co-CEO, Chairman or Co-Chairman of such entity (or of the Board of Directors of such entity), provided that such positions shall have the power to implement this Agreement when such entity is granted a sub-license hereunder, or controls or co-controls such entity; in such cases, the License shall terminate with respect to such Licensed Hotel;

and the Licensee fails to (i) remedy such breach in the case of breach of Article 9.1.1 within sixty (60) days of receipt of a written notice served by the Proprietor, (ii) to remedy such breach in case of Article 9.1.2 within one hundred and twenty (120) days of receipt of a written notice served by the Proprietor, (iii) substantially re-commence use of the Baccarat Brand within one hundred and twenty (120) days of receipt of a written notice served by the Proprietor regarding Article 9.1.3, or (iv) cease or remedy such breach or cause such breach to be ceased or remedied (in the case of a sublicensee of the Licensee being in breach) in the case of Articles 9.1.4, and 9.1.5 within sixty (60) days of receipt of a written notice served by the Proprietor.

- 9.2. The Licensee shall be authorized to early terminate this Agreement if the Proprietor is in substantial breach of any material obligation hereunder and the Proprietor fails to remedy such breach within sixty (60) days of receipt of a written notice served by the Licensee.
- 9.3. Additionally, the Licensee shall have the right, at its sole option, to terminate this Agreement effective upon the fifth anniversary of the date hereof subject to (i) ninety

Article 11. ADVERTISING, PROMOTION AND COMMUNICATION

The advertising in all media and promotion for the Licensed Hotels opened to the general public shall be made by the Licensee, at its own expense but shall be no less than an aggregate amount equal to [REDACTED] (including all advertising and promotion with respect to the sale of units in Luxury Residences) multiplied by the number of Licensed Hotels opened to the general public hereunder and such advertisement and promotion shall be allocated in such amounts to any or all Licensed Hotels as determined by Licensee in its sole discretion and further provided that [REDACTED] of such advertisement and promotion amounts shall be spent before the fifth anniversary of opening to the general public of any or all Licensed Hotels (e.g., if 5 Licensed Hotels are opened to the general public hereunder then a minimum of [REDACTED], in the aggregate, shall be required to be spent for advertisement and promotion during the entire term of 25 years (or more) as to each Licensed Hotel and [REDACTED], in the aggregate, shall be required to be spent for advertisements and promotion before the fifth anniversary of opening to the general public of any or all Licensed Hotels).

The Licensee shall regularly consult with, and shall seek approval from the task force or designee of the Proprietor on any advertising, marketing and promotional materials relating to the Licensed Hotels (including website page) to be materially consistent with the Brand image and reputation, such approval not to be unreasonably withheld or delayed, provided that any such advertising, marketing and promotional materials consistent with the Guidelines and the graphic chart as provided in Exhibit 5 shall be deemed approved.

The Licensee shall regularly consult with, and shall seek approval from the task force or designee of the Proprietor on any advertising, marketing and promotional materials relating to the Licensed Hotels (including website page) to be materially consistent with the Brand image and reputation, such approval not to be unreasonably withheld or delayed, provided that any such advertising, marketing and promotional materials consistent with the Guidelines and the graphic chart as provided in Exhibit 5 shall be deemed approved.

Article 12. SUB-LICENSING / NO ASSIGNMENT / CHANGE OF CONTROL

12.1. The Proprietor acknowledges and agrees that the Licensee shall be entitled to sub-license its rights hereof (including the License) only to any of its Affiliates anywhere in the Territory without the prior consent of the Proprietor; provided however that (i) the Licensee shall cause such Affiliates to be bound by any and all obligations under this Agreement and (ii) a substantial breach by any of its Affiliates of any obligation hereof shall be deemed to be a substantial breach by the Licensee hereunder and, if not remedied by such Affiliate (which is a sublicensee of the Licensee) in accordance with this Agreement, may trigger, in case the Licensee thereafter fails to terminate such sub-license agreement, an early termination of this Agreement prior to the expiration of the Duration or any renewal subsequent period.

For the avoidance of doubt it is provided that in such case of early termination of this Agreement, the provisions set forth in subparts (i) and (ii) of the last paragraph of Article 8 shall apply in all respects, it being agreed that the term of the License shall continue, as to any Licensed Hotel which is not the subject of such substantial breach, until twenty-five (25) years after the opening of such Licensed Hotel to the general public as a

Licensed Hotel, subject to renewal rights in accordance with the last sentence of Article 8.

All necessary information, regarding a sublicensee, to reasonably demonstrate that such sublicensee is an Affiliate of the Licensee, will be provided by Licensee to the Proprietor's Board of Directors prior to the granting of such sublicense.

- 12.2. Neither Party hereto may transfer or convey all or any rights and obligations under the Agreement without the prior written consent of the other Party, except to an entity controlled (or co-controlled) by, or under common control (or co-control) with such Party, provided that the Licensee shall (i) have the right to assign the Agreement to any entity controlled (or co-controlled) directly or indirectly, by Barry Sternlicht - or to any entity of which Barry Sternlicht is either the CEO (or co-CEO), or the Chairman (or Co-Chairman) of the Board of Directors (or other such board or supervisory committee), provided that such positions shall have the power to implement this Agreement and (ii) have the right to assign this Agreement, including all rights and obligations hereunder, to any third party after five (5) years from the date hereof provided such third party is a Qualified Hotel Operator and subject to the Proprietor's Board of Directors prior approval, such approval not to be unreasonably withheld or delayed. All necessary information regarding a transferee and/or assignee of Licensee, to reasonably demonstrate that such transferee and/or assignee meets the requirements of (i) or (ii) of this Article 12.2, will be provided by Licensee to the Proprietor's Board of Directors prior to the assignment being undertaken.
- 12.3. In case of change of control (as this term is defined in Article 1 above) of the Proprietor, the Licensee shall have the right, at its sole option, to terminate this Agreement, as regards any or all Licensed Hotels, such termination being effective within sixty (60) days of receipt of a written notice served by the Licensee to the Proprietor not later than ninety (90) days following the change of control event.
- 12.4. In case of change of control (as this term is defined in Article 1 above), except in the case of the death or disability of Barry Sternlicht, of the Licensee, the Proprietor shall have the right, at its sole option, to terminate this Agreement, such termination being effective sixty (60) days of receipt of a written notice served by the Proprietor to the Licensee not later than ninety (90) days following the change of control event provided that such termination right shall not be permitted to be exercised by the Proprietor if upon such change in control the Licensee is controlled or co-controlled, directly or indirectly, by Barry Sternlicht or Barry Sternlicht serves as either chairman or co-chairman of such entity's Board of Directors or other such board or supervisory committee or to an entity of which Barry Sternlicht serves as CEO or Co-CEO, provided that such positions shall have the power to implement this Agreement.

Article 13. PROTECTION OF THE BRAND

- 13.1. The Proprietor shall undertake, at its expense, all the formalities necessary to register, renew, defend and or maintain in force the Brands in the Territory during the Duration and the term of any renewal, if any.

The Licensee shall, each time it is necessary and upon simple request by the Proprietor, provide the Proprietor with all the assistance necessary to maintain the Brands in force and to provide it with all the required documents, particularly any proof of using the Brands.

- 13.2. The parties shall notify each other immediately of any apparent infringement of the Brand that may come to its knowledge, and of any claim by any third party.

The Proprietor and the Licensee shall fully co-operate in the protection and defence of the Brand in the Territory, it being understood that the Proprietor shall take all necessary steps to defend the Brand against any unauthorized use and the Licensee shall provide its commercially reasonable efforts at its own internal cost to assist the Proprietor in any litigation regarding the infringement of the Brands, provided, however, that all third party costs incurred by Licensee or Proprietor shall be paid by Proprietor. The Party shall consult each other in order to organize the management of any legal suits regarding the infringement of the Brands and to examine the possibility of conducting any settlement agreement with third parties.

Article 14. INDEMNIFICATION

The Licensee, acting on its own behalf as well as on behalf of the Affiliates, shall indemnify the Proprietor for any costs, expenses, losses or damages incurred or paid by the Proprietor as a result of (i) the operation by the Licensee and/or the Affiliates of the Licensed Hotel, or (ii) a breach by the Licensee and/or any of its Affiliates of any law or regulation applicable to the operation of the Licensed Hotels or any provision of this Agreement.

Article 15. PURCHASE AGREEMENT

The Licensee shall purchase Baccarat Brand products from the Proprietor or any of its designated Affiliate including inter alia, lighting, chinaware and tableware, in order to furnish each Licensed Hotel. The Licensee shall have a minimum purchase obligation of [REDACTED] ("the Minimum Purchase Obligation") of Baccarat Brand products per unit (room) of any such Licensed Hotel. The purchase price of Baccarat Brand products subject to such Minimum Purchase Obligation shall be the applicable local wholesale price (according to the published wholesale price list) in effect at the time of such purchase order(s). Such Minimum Purchase Obligation may be satisfied, in an aggregate basis, at any place in any of the Licensed Hotels, not necessarily in each room of Licensed Hotels.

Article 16. SEVERABILITY

Any provision of this Agreement which is prohibited or unenforceable in any jurisdiction shall, as to such jurisdiction, be ineffective to the extent of such prohibition or unenforceability without invalidating the remaining provisions hereof, and any such prohibition or unenforceability in any jurisdiction shall not invalidate or render unenforceable such provision in any other jurisdiction.

Article 17. REGISTRATION OF LICENSE

The License shall be registered at the Licensee's cost as soon as practically possible following the execution of this Agreement with the National Brands Registry ("*registre national des*

marques”) and the various applicable national and international trademark offices. The Proprietor shall provide and sign all documents necessary to accomplish such registration publicities, upon the Licensee’s first request.

Article 18. MISCELLANEOUS

- 18.1. This Agreement (including its preamble entitled “Whereas” and all Exhibits thereto), together with any documents referred to therein, constitute the whole agreement between the Parties relating to their subject matter and supersede and extinguish any prior drafts, agreements, undertakings, representations, warranties and arrangements of any nature, whether in writing or oral, relating to such subject matter.
- 18.2. No failure to exercise nor any delay in exercising by either Party to this Agreement of any right, power, privilege or remedy under this Agreement shall impair or operate as a waiver of such right, power, privilege or remedy.
- 18.3. No variation of this Agreement shall be effective unless made in writing and executed by both Parties.

Article 19. COST AND EXPENSES

Except if stipulated otherwise in this Agreement, all documented costs, fees (including registration and notification fees), duties and taxes resulting from the execution and performance of this Agreement or any amendment related thereto will be borne by the Licensee, except for any income taxes or withholding on the payments contemplated hereunder.

Article 20. NOTICES

Any notices to be sent pursuant to the provisions of the Agreement shall be in writing and shall be validly delivered if sent by registered mail with return receipt requested, or by facsimile confirmed by registered mail with return receipt requested (sent no later than on the next Business Day), to the following addresses.

Article 21. GOVERNING LAW – JURISDICTION


- 21.1. This Agreement and the License constituted herein shall be construed and governed by the laws of the France.

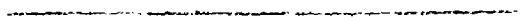
