PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS

This PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of December 10, 2009 (“Effective Date”) by **WELLS FARGO FOOTHILL, LLC**, a Delaware limited liability company (“Grantee”), in favor of the Grantors listed on Schedule A hereto (collectively, jointly and severally, the “Grantors” and each, individually, a “Grantor”). Capitalized terms used in this Release, but not defined herein, shall have the respective meanings ascribed to them in the Trademark Security Agreement or Security Agreement referred to below, as applicable.

WHEREAS, the Grantors and Grantee, among other parties, entered into that certain Credit Agreement (as amended, restated, supplemented or otherwise modified from time to time) and that certain Security Agreement (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”), each dated as of June 30, 2009;

WHEREAS, pursuant to the Security Agreement, the Grantors were required to execute and deliver to Grantee, for the benefit of Lender Group and the Bank Product Providers, that certain Trademark Security Agreement;

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement dated as of June 30, 2009 (as amended, restated, supplemented or otherwise modified from time to time, the “Trademark Security Agreement”), by and among the Grantors and Grantee, each Grantor unconditionally granted, assigned, and pledged to Grantee, for the benefit of the Lender Group and each of the Bank Product Providers, to secure the Secured Obligations, a continuing security interest (“Security Interest”) in all of such Grantor’s right, title and interest in and to the Trademark Collateral, including, without limitation, the trademark registrations and applications listed on Schedule B hereto (the “Specified Trademarks”);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 6, 2009 at Reel 004017, Frame 0082;

WHEREAS, pursuant to that certain certificate dated as of December 9 2009, Stock Building Supply, LLC, a North Carolina limited liability company, (a) has certified on behalf of the Grantors that no Grantor owned any interest in the Specified Trademarks as of June 30, 2009 or at any time thereafter through December 9, 2009 and (b) has requested that Grantee release its Security Interest in and any and all of the liens held or purported to be held by Grantee on the Specified Trademarks; and

WHEREAS, Grantee has agreed to release its Security Interest in the Specified Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby releases its Security Interest in and to any and all claims, liens, security interests and other encumbrances on the Specified Trademarks granted by the Grantors to Grantee pursuant to the Trademark Security Agreement.

Grantee hereby authorizes the Grantors or the Grantors’ authorized representative to record this Release with the United States Patent and Trademark Office.

THIS AGREEMENT AND THE RIGHTS AND OBLIGATIONS OF THE GRANTEE HEREUNDER SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK. GRANTEE AGREES THAT THE PROVISIONS OF THE TRADEMARK SECURITY AGREEMENT WITH RESPECT TO VENUE AND JURY TRIAL WAIVER ARE APPLICABLE TO THIS AGREEMENT AS IF FULLY SET FORTH HEREIN.
