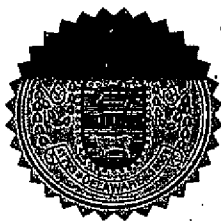

The undersigned, the Chief Executive Officer of Saleen Incorporated, a Delaware corporation, hereby certifies in connection with the merger of Saleen Incorporated, a Delaware corporation, and Saleen Incorporated, a California corporation, that:

1. The name and state of incorporation of each of the constituent corporations of the merger is as follows:

2. An agreement of merger has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations in accordance with the requirements of Section 252 of the General Corporation Law of the State of Delaware.

3. The name of the surviving corporation of the merger is Saleen Incorporated, a Delaware corporation.

4. The Certificate of Incorporation of Saleen Incorporated, the surviving corporation, as now in force and effect, shall continue to be the Certificate of Incorporation of said surviving corporation until amended and changed pursuant to the provisions thereof and the General Corporation Law of the State of Delaware.

5. The executed agreement of merger is on file at the principal place of business of the surviving corporation. The principal place of business of the surviving


corporation at which the agreement of merger is filed is 76 Fairbanks, Irvine, California, 92618.

6. A copy of the agreement of merger will be furnished by the surviving corporation, on request and without cost to any stockholder of any constituent corporation.

7. The authorized capital stock of the constituent corporation that is not surviving the merger, Saleen Incorporated, a California corporation, is 2,500,000 shares of Common Stock and 300,000 shares of Preferred Stock.
