RHI hereby transfers, assigns, conveys and delivers, to RP, and RP accepts from RHI, all of RHI's rights, title and interest in and to the Trademark Rights and in and to the goodwill of the business associated with the use of, and symbolized by, the Trademark Rights, including the right to sue others for past acts of infringement of

the Trademark Rights and to retain all revenues received from others for past acts of infringement of the Trademark Rights.

2. RHI further agrees for itself, successors, assigns, and its legally bound predecessors to execute, without further consideration, any further legal documents, any further assignments, and any releases, declarations, renewals or other applications for Trademark Rights that may be deemed necessary by RP, or by RP's successors-in-interest or assigns, fully to secure to RP, or to RP's successors-in-interest or assigns, RHI's interest as aforesaid in and to the Trademark Rights and in and to the goodwill of the business associated with the use of, and symbolized by, the Trademark Rights.
