Terri L. Slane hereby certifies that:


- A. She is the duly elected Assistant Secretary of Barclays Global Investors, National Association (the "Association").

The title of the Association shall be BlackRock Institutional Trust Company, National Association."



The Office of the Comptroller of the Currency (OCC) has received your letter dated December 1, 2009, concerning the title change and the appropriate amendment to the Articles of Association. We have updated our records to reflect that as of December 1, 2009, the title of Barclays Global Investors, National Association, San Francisco, California, changed to BlackRock Institutional Trust Company, National Association.

As a result of the Garn-St Germain Depository Institutions Act of 1982, the OCC is no longer responsible for the approval of national bank name changes nor does it maintain official records on the use of alternate titles. The use of other titles or the retention of the rights to any previously used title is the responsibility of the bank's board of directors. Legal counsel should be consulted to determine whether or not the new title, or any previously used title, could be challenged by competing institutions under the provisions of federal or state law.
