RELEASE OF SECURITY INTEREST

The Collateral Agent hereby assigns unto the Grantors its entire right, title and interest in and to the Trademarks.

The Collateral Agent will execute such Uniform Commercial Code termination statements as the Grantors may reasonably request in order to terminate any security interest the Collateral Agent may have in and to the Trademarks and to execute such other documents and instruments, and take other such actions (at the expense of the Grantors) as the Grantors may reasonably request to evidence this termination and release and the release of any security interests in the Trademarks.
