ARTICLES OF AMENDMENT

FOR

RESCARE, INC.

TO THE SECRETARY OF STATE OF THE STATE OF IOWA:

Pursuant to Sections 490.1003 and 490.1006 of the Iowa Business Corporation Act, as amended (the "Act"), the undersigned corporation (the "Corporation") hereby adopts the following amendment to the Corporation's Articles of Incorporation:

- 1. Name of Corporation. The name of the Corporation before this amendment of its Articles of Incorporation is ResCare, Inc.
- 2. Amendment to Articles of Incorporation. Article I of the Corporation's Articles of Incorporation is hereby deleted and replaced with the following:

"The name of the Corporation is Optimaae LifeServices, Inc."
- 3. Date of Adoption. The amendment was adopted by the Corporation's Directors and Shareholders on July 2, 2009.
- 4. Shareholder Approval. The amendment was duly approved by the Shareholders in the manner required by the Act and by the Corporation's Articles of Incorporation.
- 5. Effective Date. These Articles of Amendment are effective on the date of their filing with the Iowa Secretary of State.
