Whereas, Assignee has been using the Assigned Mark and such use has inured to the benefit of the Assignor, which is a company related to Assignee, and


Whereas, Assignor desires to assign, convey, transfer and deliver the Assigned Mark to Assignee in accordance with the terms of this Assignment.

Now therefore, in consideration of the premises, and for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:


