GRANT OF SECURITY INTEREST
TRADEMARKS

THIS GRANT OF SECURITY INTEREST, dated as of December 4, 2009, is executed by WHITEFENCE, INC., a Delaware corporation with an address of 5333 Westheimer, Suite 100, Houston, Texas 77056 (“Debtor”), in favor of INTERNET CAPITAL GROUP OPERATIONS, INC., a Delaware corporation with an address of 690 Lee Road, Suite 310, Wayne, Pennsylvania 19087, as administrative agent (“Secured Party”).

A. Pursuant to a certain Note and Warrant Purchase Agreement, dated on or about the date hereof (the “Agreement”) by and between Debtor, the purchasers from time to time party thereto (the “Purchasers”), and the Secured Party, as agent for the Purchasers, the Purchasers have agreed to extend certain credit facilities to Debtor upon the terms and subject to the conditions set forth therein;

B. Debtor owns the registered trademarks, service marks (and applications and registrations therefor), of the United States, more particularly described on Schedules 1-A and 1-B annexed hereto as part hereof (collectively, the “Trademarks”);

C. Pursuant to the Agreement, Debtor has granted to Secured Party, on behalf of the Purchasers, a security interest in all right, title and interest of Debtor in and to the Trademarks, together with associated goodwill, and all proceeds thereof, including any and all causes of action which may exist by reason of infringement thereof for the full term of the Trademarks (the “Collateral”), to secure the prompt payment, performance and observance of the Obligations (as defined in the Agreement);


NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Debtor does hereby further grant to Secured Party a security interest in the Collateral to secure the prompt payment, performance and observance of the Obligations.

Debtor does hereby further acknowledge and affirm that the rights and remedies of Secured Party with respect to the security interest in the Collateral granted hereby are more fully set forth in the Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.
