TRADEMARK ASSIGNMENT

Assignor further warrants that the Assignor has not knowingly conveyed to others any right in said Trademark or any license to use the same; and that the Assignor has good right to assign the Trademark to the Assignee without encumbrances.

Assignor further covenants that, at the expense of the Assignee, it will execute all documents, papers, forms and authorizations and take all other actions that may be necessary for securing, completing, or vesting in Assignee full right, title, and interest in and to the Trademark.
