**TERMINATION AND RELEASE  
OF SECURITY INTEREST IN TRADEMARKS**

THIS TERMINATION AND RELEASE dated as of December 14, 2009, from General Electric Capital Corporation ("GE Capital"), in its capacity as administrative agent (in such capacity, together with its successors and permitted assigns, the "Administrative Agent") for the Lenders (as defined in the Credit Agreement, dated as of July 15, 2005 (as amended, restated, supplemented, or otherwise modified from time to time, the "Credit Agreement")) to Equitrac Corporation, a Florida corporation (the "Grantor").

WITNESSETH:

WHEREAS, pursuant to the Security Agreement dated as of July 15, 2005 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), and the Trademark Security Agreement dated as of July 15, 2005, in favor of Administrative Agent (the "Trademark Security Agreement"), a security interest (the "Security Interest") was granted by Grantor to GE Capital in the Trademark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded with the Assignment Division of the United States Patent and Trademark Office at Reel 3124, Frame 0664 on July 20, 2005;

WHEREAS, the Trademark Security Agreement was recorded with the Canadian Intellectual Property Office on November 7, 2005;

WHEREAS, the Trademark Security Agreement was recorded as Security Interest No. 497 with the Trade Mark Registry, Intellectual Property Department, The Government of the Hong Kong Special Administrative Region, on October 16, 2006;

WHEREAS, pursuant to the Security Agreement dated as of January 4, 2006 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Second Security Agreement"), and the Trademark Security Agreement dated as of January 4, 2006, in favor of Administrative Agent (the "Second Trademark Security Agreement"), a security interest (the "Second Security Interest") was granted by Grantor to GE Capital in the Trademark Collateral (as defined in the Second Trademark Security Agreement);

WHEREAS, the Second Trademark Security Agreement was filed with the United Kingdom Intellectual Property Office on January 24, 2006; and

WHEREAS, GE Capital now desires to terminate and release the entirety of its Security Interest and Second Security Interest in the Trademark Collateral as defined in the Trademark Security Agreement and the Second Trademark Security Agreement;

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the

Trademark Security Agreement and the Second Trademark Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, GE Capital hereby states as follows:

1. Definitions. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Credit Agreement, the Trademark Security Agreement, and the Second Trademark Security Agreement.

2. Release of Security Interest. GE Capital hereby terminates, releases, and discharges its Security Interest and Second Security Interest in the Trademark Collateral as defined in the Trademark Security Agreement and the Second Trademark Security Agreement, including the trademark collateral listed in Exhibit 1 attached hereto. Any and all right, title, or interest of GE Capital in such Trademark Collateral and all proceeds thereof, including without limitation, the goodwill of the business connected with the use of, and symbolized by, the Trademark Collateral and any and all causes of action which may exist by reason of infringement of the Trademark Collateral, shall hereby cease and become void.

3. Further Assurances. GE Capital hereby agrees to duly execute, acknowledge, procure, and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest and the Second Security Interest in the Trademark Collateral contemplated hereby.
