
WHEREAS, ASSIGNEE is desirous of acquiring said trademarks;

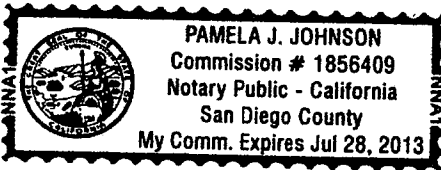

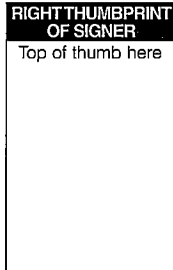

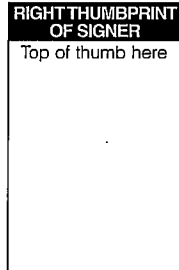
