NUNC PRO TUNC ASSIGNMENT OF TRADEMARKS AND UNITED STATES REGISTRATIONS

WHEREAS, MURRAY L. NEAL, an individual residing at 681 East Brighton Lane, Fresno, California 93720 (hereinafter referred to as "ASSIGNOR"), acquired, adopted and used, and thereby, owns all rights, title and interests in and to the U.S. trademarks identified in Schedule "A" attached hereto by the foregoing reference, incorporated herein (hereinafter referred to individually and collectively as the "Marks" and "Registrations"), along with the goodwill of the business appurtenant to said Marks; and

WHEREAS, ASSIGNOR is assigning the marks as part of the entire business to which the marks pertain as required by 15 U.S.C. §1060; and

WHEREAS, ASSIGNOR assigned his entire rights, titles and interests in and to the Marks and Registrations and the goodwill associated therewith on or about August 26, 2009, to American Development Group International, LLC, a limited liability company organized and existing under the laws of the State of Delaware, having a principal business address at 2550 M Street N.W., Suite 500, Washington, District of Columbia 20037 ("ASSIGNEE"); and

WHEREAS, ASSIGNEE's acquisition of the Marks and Registrations was not formally documented, nor made of record in the United States Patent & Trademark Office ("USPTO"); and

WHEREAS, ASSIGNEE desires to formalize, legally, its ownership of the Marks and Registrations thereof, nunc pro tunc, August 26, 2009, and to make its ownership thereof of record in the USPTO; and

WHEREAS, ASSIGNOR is willing to execute this instrument of assignment for the purpose of (i) formalizing ASSIGNEE's legal ownership of the Marks and Registrations thereof, nunc pro tunc, August 26, 2009, and (ii) enabling ASSIGNEE to make its ownership of the Marks and Registrations thereof of record in the USPTO.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, ASSIGNOR does hereby sell, assign, convey and transfer unto ASSIGNEE, its successors, assigns and legal representatives, the full and entire rights, titles and interests in and to the Marks, together with the goodwill of the business symbolized by the Marks, and the Registrations thereof, nunc pro tunc, August 26, 2009.
