U.S. TRADEMARK ASSIGNMENT AGREEMENT

Hollander Home Fashions Corp. ("HHF Corp."), a corporation of the State of New Jersey, having a place of business at 6560 West Rogers Circle, Boca Raton, FL 33487, has adopted, used or intends to use and is the record owner of trademarks in the United States, including but not limited to trademark registrations and applications listed in attached Exhibit A, and all the goodwill associated with all the foregoing (collectively hereafter the "Trademarks and Goodwill").

Hollander Home Fashions, LLC ("HHF, LLC"), a limited liability company of the State of Delaware, having a principal place of business at 6560 West Rogers Circle, Boca Raton, FL 33487, is desirous of obtaining all rights of HHF Corp. to the Trademarks and Goodwill and is desirous of recording its name as record owner of such applications and registrations.

The parties acknowledge and agree as follows:

1. HHF Corp. hereby irrevocably assigns and shall be deemed to have assigned to HHF, LLC, *nunc pro tunc*, the entire right, title, and interest to the Trademarks and Goodwill including that portion of the ongoing and existing business of HHF Corp. pertinent to all products and services with which the Trademarks and Goodwill have been, are and will be used to the fullest extent permitted by law. For clarity, the Trademarks and Goodwill include common law and statutory rights in the Trademarks and Goodwill and variants thereof, and the goodwill pertaining thereto to the fullest extent permitted by law as if such rights would have been held by HHF Corp. had this assignment not been made. HHF, LLC accepts the assignment granted herein. This assignment includes all rights to recover and collect all monies associated with past damages, royalties or other pecuniary matters.
2. HHF Corp. retains no rights whatsoever to the Trademarks and Goodwill or any other rights assigned in Paragraph 1 above.

3. HHF, LLC has the full and unencumbered right, as it deems fit, to register, enforce, or protect the rights transferred hereunder in the United States, including without limitation, the right to sue or bring actions for past, present or future infringement thereof, and to bring any proceeding in the United States Patent and Trademark Office or any other equivalent governmental agency for cancellation or opposition, or other proceeding in connection with the Trademarks and Goodwill.

4. HHF Corp. shall execute documents and provide other cooperation as HHF, LLC shall reasonably request to confirm its ownership in the Marks, including all confirmatory assignments and all other necessary papers.

5. Both HHF Corp. and HHF, LLC acknowledge that sufficient consideration has been exchanged between them.
