## RELEASE OF SECURITY INTEREST

This Release of Security Interest is made as of December 21, 2009, by Deutsche Bank Trust Company Americas, formerly known as Bankers Trust Company, located at 130 Liberty Street, New York, New York 10006, as Collateral Agent ("COLLATERAL AGENT"), in favor of ECCA Enterprises, Inc., a Delaware corporation, located at 103 Faulk Road, Suite 202, Wilmington, Delaware 19803 (referred to as "COMPANY").

WHEREAS, Eye Care Centers of America, Inc. and COLLATERAL AGENT entered into that certain Assignment of Security Interest in United States Trademarks and Patents dated as of April 24, 1998, which was recorded with the United States Patent and Trademark Office on May 18, 1998 at Reel 1734 and Frame 0033 (the "Security Agreement");

WHEREAS, under the Security Agreement, COMPANY granted to COLLATERAL AGENT a certain security interest in, among other things, the COMPANY'S "Marks," as defined pursuant to the Security Agreement, which includes without limitation United States Trademark Application Serial No. 75/259,540 for the mark BOARDROOM CLASSICS, which matured to United States Trademark Registration No. 2,199,419 on October 27, 1998 (the "Collateral");

WHEREAS, Eye Care Centers of America, Inc. assigned its entire interest in the Collateral to COMPANY on April 23, 2003 and recorded that assignment in the United States Patent and Trademark Office on May 19, 2003 at Reel 2736 and Frame 0687;

WHEREAS, COLLATERAL AGENT recorded its change of name from Bankers Trust Company to Deutsche Bank Trust Company Americas in the United States Patent and Trademark Office on May 12, 2005 at Reel 3082 and Frame 0317 (the "Name Change");

WHEREAS, the Name Change was recorded against certain other of the COMPANY'S Marks, excluding the Collateral;

WHEREAS, COLLATERAL AGENT assigned its security interest in certain other of the COMPANY'S Marks to Fleet National Bank on December 23, 2002 and recorded that assignment in the United States Patent and Trademark Office on December 23, 2002 at Reel 2640 and Frame 0970 (the "Assignment"); and

WHEREAS, COMPANY has satisfied all of its obligations to COLLATERAL AGENT under the Security Agreement, the Collateral was inadvertently excluded from the Name Change and the Assignment, and COLLATERAL AGENT wishes to release all interest that COLLATERAL AGENT may have in the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, COLLATERAL AGENT hereby releases any and all of its right, title, and interest in and to the Collateral.
