RELEASE OF ASSIGNMENT FOR SECURITY OF TRADEMARKS

THIS RELEASE is made as of this 22nd day of December, 2009, by MADISON CAPITAL FUNDING LLC, as Agent ("Madison") in favor of ONE CALL MEDICAL, INC. ("Company"), a New Jersey corporation, pursuant to the termination of the Guarantee and Collateral Agreement, dated as of December 14, 2006, among Company, Madison and certain additional parties thereto (including all annexes, exhibits or schedules thereto, as from time to time amended, restated supplemented or otherwise modified, the "Collateral Agreement").

WHEREAS, pursuant to the Collateral Agreement, the Company granted to Madison a security interest in and lien on certain property and assets of the Company, including those trademark registrations listed on Schedule A hereto.

WHEREAS, pursuant to the Collateral Agreement, the Company executed a Trademark Security Agreement, dated as of December 14, 2006 (the "Trademark Security Agreement") in favor of Madison, which was recorded with the United States Patent and Trademark Office; and

WHEREAS, in connection with the Company's satisfaction of its obligations thereunder, the Collateral Agreement has terminated, other than with respect to those provisions that specifically survive termination.

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Madison hereby unconditionally and expressly releases, terminates, and extinguishes any and all of its right, title and interest in and to any and all liens and security interests it may have upon the Trademark Collateral (as defined in

the Trademark Security Agreement), including the trademarks registrations listed on Schedule A attached hereto and made a part hereof (collectively, the "Released Collateral").

Madison consents and agrees to execute and deliver, at the request and cost of Company, such further instruments, documents and release forms as Company may reasonably request to more effectively, release, terminate and extinguish any such liens and security interests upon the Released Collateral.

This Release shall be binding upon Madison's legal representatives, assigns and successors.
