## **SECOND LIEN TRADEMARK SECURITY AGREEMENT**

This SECOND LIEN TRADEMARK SECURITY AGREEMENT, dated as of December 23, 2009 (this "Agreement"), is made between Spyder Active Sports, Inc., a Colorado corporation (the "Grantor"), in favor of Antares Capital Corporation, as collateral agent (together with its successor(s) thereto in such capacity, the "Secured Party") for each of the Purchasers (as defined below).

### **Recitals**

A. Pursuant to that certain Note and Equity Purchase Agreement dated as of September 10, 2004 (as amended, restated, supplemented or otherwise modified from time to time, including as amended by that certain Waiver and Fourth Amendment to Note and Equity Purchase Agreement dated as of even date herewith, the "Purchase Agreement"), among the Grantor and the Purchasers named therein, the Purchasers have made, and agree to continue to make, certain financial accommodations available to the Grantor;

B. Pursuant to that certain Second Lien Guaranty dated as of the date hereof (as amended, restated, supplemented or otherwise modified from time to time, the "Guaranty"), among the Grantor, the Secured Party, as collateral agent for the Purchasers, and certain other parties, Grantor has guaranteed the Obligations (as defined below) owed to the Purchasers.

C. The obligation of the Purchasers to continue to make available the financial accommodations under the Purchase Agreement is subject to the condition, among others, that the Grantor secure the Obligations (as defined below) in the manner set forth herein; and

D. The Grantor has duly authorized the execution, delivery and performance of this Agreement.

### **Agreement**

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantor agrees, for the benefit of the Secured Party and the ratable benefit of each of the Purchasers, as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Agreement, including its preamble and recitals, have the meanings provided in Second Lien Security Agreement, dated as of the date hereof, by and between the Grantor and the Secured Party (as amended, restated, supplemented restated or otherwise modified from time to time, the "Security Agreement"), or, if not defined in the Security Agreement, then in the Purchase Agreement.

As used herein, "Obligations" means all "Obligations" under and as defined in the Purchase Agreement.

SECTION 2. Grant of Security Interest. As security for the due and punctual payment and performance of the Obligations in full, whether at stated maturity, by required prepayment, declaration, acceleration, demand or otherwise (including any payment of amounts that would

become due but for the operation of the automatic stay under Section 362(a) of the United States Bankruptcy Code (or any successor provision)), the Grantor hereby grants to and creates in favor of the Secured Party, for its benefit and the ratable benefit of each of the Purchasers, a continuing Lien on and security interest under the Code in and to all of the following property (subject only to the superior priority of certain Permitted Liens), whether now existing or hereafter acquired by the Grantor (the "Trademark Collateral"):

(a) (i) all of Grantor's trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, certification marks, collective marks, logos and other source or business identifiers, now existing or hereafter adopted or acquired including those referred to in Item A of Schedule I hereto, whether currently in use or not, all registrations and recordings thereof and all applications in connection therewith, whether pending or in preparation for filing, including registrations, recordings and applications in the United States Patent and Trademark Office or in any office or agency of the United States of America or any State thereof or any other country or political subdivision thereof or otherwise, and all common-law rights relating to the foregoing, and (ii) the right to obtain all reissues, extensions or renewals of the foregoing (collectively referred to as the "Trademarks");

(b) all of its Trademark licenses, and other agreements providing the Grantor with the right to use any items of the type referred to in clause (a) above, including each patent license referred to in Item B of Schedule I attached hereto; and

(c) all of the goodwill of the business connected with the use of, and symbolized by the Trademarks;

(d) the right to sue third parties for past, present and future infringements of any Trademark Collateral described in clause (a) and, to the extent applicable, clauses (b) and (c); and

(e) all proceeds of, and rights associated with, the foregoing rights described in clauses (a), (b), (c) and (d), including any claim by the Grantor against third parties for past, present or future infringement or dilution of any Trademark, Trademark registration or Trademark license, or for any injury to the goodwill associated with the use of any such Trademark or for breach or enforcement of any Trademark license and all rights corresponding thereto throughout the world.

provided, that, the term "Trademark Collateral" shall not include any U.S. trademark or service mark application, to the extent the security interest granted hereunder would cause the invalidation of such trademark or service mark application, until such time as a statement to allege use (or the equivalent) in respect thereof has been filed with, and accepted by, the United States Patent and Trademark Office; provided, further, that the Trademark Collateral shall include any and all proceeds of the interests described in the foregoing clause to the extent that the assignment or encumbering of such proceeds would not cause such invalidation.

SECTION 3. Representations. Upon the execution and delivery of this Agreement and all related UCC-1 financing statements, the Secured Party's security interest in the Trademark Collateral conferred hereby will be a valid, perfected (to the extent perfection may be achieved by filing UCC-1 financing statements or appropriate documents (including, without limitation, this Agreement) with the United States Patent and Trademark Office or Copyright Office), security interest, subject to Permitted Liens. No effective financing statement or other instrument similar in effect covering all or any part of the Trademark Collateral is on file in any recording office except such as may have been filed in favor of the Secured Party relating to this Agreement or to perfect or protect any security interest expressly permitted by the Purchase Documents.

SECTION 4. Security Agreement. This Agreement has been executed and delivered by the Grantor for the purpose of registering the security interest of the Secured Party in the Trademark Collateral with the United States Patent and Trademark Office and corresponding offices in other countries of the world, and in connection therewith, the Grantor hereby authorizes the Secured Party to file this Agreement with all offices deemed necessary by the Secured Party. The security interest granted hereby has been granted as a supplement to, and not in limitation of, the security interest granted to the Secured Party for its benefit and the ratable benefit of each of the Purchasers under the Security Agreement. The Security Agreement (and all rights and remedies of the Secured Party thereunder) shall remain in full force and effect in accordance with its terms.

SECTION 5. Release of Liens. Upon (i) the disposition of Trademark Collateral in accordance with the Senior Credit Agreement or (ii) no Obligations remaining outstanding (other than contingent indemnification obligations not yet due and payable) under the Purchase Documents, the security interests granted herein shall automatically terminate with respect to (A) such Trademark Collateral (in the case of clause (i) of this Section 5) or (B) all Trademark Collateral (in the case of clause (ii) of this Section 5). Upon any such disposition or termination, the Secured Party will, at the Grantor's sole expense, deliver to the Grantor, without any representations, warranties or recourse of any kind whatsoever, all Trademark Collateral held by the Secured Party hereunder, and execute and deliver to the Grantor such documents as the Grantor shall reasonably request to evidence such termination.

SECTION 6. Acknowledgment. The Grantor does hereby further acknowledge and affirm that the rights and remedies of the Secured Party with respect to the security interest in the Trademark Collateral granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which (including the remedies provided for therein) are incorporated by reference herein as if fully set forth herein.

SECTION 7. Purchase Document. This Agreement is a Purchase Document executed pursuant to the Purchase Agreement and shall (unless otherwise expressly indicated herein) be construed, administered and applied in accordance with the terms and provisions thereof.

SECTION 8. Counterparts. This Agreement may be executed by the parties hereto in several counterparts, each of which shall be deemed to be an original and all of which shall constitute together but one and the same agreement

SECTION 9. Legend. Anything herein to the contrary notwithstanding, the liens and security interests securing the Obligations, the exercise of any right or remedy with respect thereto, and certain of the rights of the Secured Party hereunder are subject to the provisions of the Amended and Restated Subordination Agreement dated as of even date herewith (as amended, restated, supplemented, or otherwise modified from time to time, the "Subordination Agreement"), by and among, inter alia, KeyBank National Association, as Senior Agent, and the Purchasers.

SECTION 10. Subordination Agreement. The Secured Party and the Senior Agent have entered into the Subordination Agreement. To the extent any provision of this Agreement conflicts with the Subordination Agreement, the Subordination Agreement shall control. Without limiting the generality of the foregoing, until the payment in full in cash of the Senior Indebtedness and the termination of the Senior Credit Documents and the commitments to lend thereunder, (a) any assignment or transfer of Collateral hereunder to the Secured Party shall be to the Senior Agent, (b) any request or consent of the Secured Party required or made hereunder shall be deemed to be required or made by the Senior Agent, (c) any delivery of any Collateral or any other item to the Secured Party required hereunder shall be to the Senior Agent, (d) any right of the Secured Party to require a Grantor to cause the Secured Party to obtain exclusive control of any Investment Property shall be vested in the Senior Agent, (e) any right of the Secured Party to assert any claims on behalf of a Grantor shall be vested in the Senior Agent, (f) the Secured Party (or its nominee) shall not exercise any rights pursuant to its appointment as attorney-in-fact pursuant to this Agreement, (g) the Secured Party shall not exercise any voting or other consensual rights set forth in this Agreement in respect of any Collateral and (h) all items required to be delivered to the Secured Party hereunder, including without limitation, stock certificates, distributions, dividends, instruments, chattel paper or other property paid or payable with respect to any of the Collateral shall be delivered to the Senior Agent as contractual representative for purposes of perfection for the Secured Party and the other Purchasers. If, as a result of this paragraph, a Grantor is required to violate or breach any other term of this Agreement or any other Purchase Document, such violation or breach shall not constitute a Default or Event of Default to such extent.


