Nothing contained herein shall be deemed to supersede any of the terms contained in the Asset Purchase Agreement. In the event of any conflict or inconsistency between the provisions of this Assignment and the provisions of the Asset Purchase Agreement, the provisions of the Asset Purchase Agreement shall prevail. Except to the extent that federal law preempts state law with respect to the matters covered hereby, this Assignment shall be governed by and construed in accordance with the laws of the State of Michigan, regardless of the laws that might otherwise govern under applicable principles of conflicts of law, as to all matters, including but not limited to matters of validity, construction, effect, performance and remedies.






