Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to the Articles of Incorporation:

1. The name of the corporation is CREATIVE BEAUTY INNOVATIONS, INC.
2. The following amendment to the Articles of Incorporation was adopted by all of the directors and shareholders of the corporation on December 22, 2004. This amendment changes the name of the corporation.
3. This amendment alters or changes Article One of the original Articles of Incorporation and the full text of Article One, as amended, is as follows:

"ARTICLE ONE

The name of the corporation is PREMIER FULFILLMENT, INC."

4. The number of shares of the corporation outstanding at the time of the adoption of this Amendment was Ten Thousand (10,000), and the number of shares entitled to vote thereon was Ten Thousand (10,000). The number of shares that voted for such amendment was Ten Thousand (10,000) and the number of shares that voted against such amendment was zero (0). No shares were entitled to vote as a class.
5. The holders of all of the shares outstanding and entitled to vote on said amendment have signed a consent in writing adopting said amendment.
