TERMINATION OF SECURITY INTERESTS IN TRADEMARKS

This Termination of Security Interests in Trademarks (this "**Termination**") is made and entered into to be effective as of December __, 2009 (the "**Effective Date**"), by Prospect Capital Corporation, a Maryland corporation (successor-by-merger to Patriot Capital Funding, Inc., a Delaware corporation), as agent ("**Patriot Capital**"), for the benefit of Quartermaster, Incorporated, a Delaware corporation ("**Quartermaster**").

Background:

1. On or about December 16, 2005, Patriot Capital and Quartermaster entered into a Senior Secured Loan Agreement (the "**Loan Agreement**") and certain other documents, including an Intellectual Property Security Agreement (the "**Intellectual Property Security Agreement**"). The Intellectual Property Security Agreement evidenced Patriot Capital's security interest in the United States issued Trademark (the "**Trademark Collateral**") listed on **Schedule I**, attached hereto and made a part hereof. The Intellectual Property Security Agreement was subsequently recorded with the United States Patent and Trademark Office.

2. Patriot Capital now desires to terminate its security interests in the Trademark Collateral.


NOW, THEREFORE, for good and valuable consideration, in consideration of the foregoing and in consideration of the mutual covenants contained herein, Patriot Capital makes the following termination:

Termination

Patriot Capital hereby terminates its security interests in the Trademark Collateral and authorizes the United States Patent and Trademark office to cancel the Notice of Grant of Security Interest in Trademarks (or any such similar document) recorded in connection with the Intellectual Property Security Agreement.
