**TRADE-MARKS ASSIGNMENT AGREEMENT**

**THIS AGREEMENT** dated the 29<sup>th</sup> day of May, 2009

**OF THE SECOND PART**

**WHEREAS** under and by virtue of an agreement of purchase and sale, dated as of the 5<sup>th</sup> day of May, 2009 between the Sertapak Inc. and the Assignee, Sertapak Inc. agreed to sell to the Assignee certain assets as more particularly described in the said agreement (the "Transaction");

**AND WHEREAS** the Assignor is a wholly-owned subsidiary of Sertapak Inc.;

**AND WHEREAS** the Transaction includes certain trade mark rights, including the trade marks described in Schedule "A" attached hereto (the "Trade-marks") which are registered in the name of the Assignor but are and always have been held by the Assignor for Sertapak Inc., as beneficial owner thereof, and Sertapak Inc. has requested the Assignor to transfer the Trade Marks to the Assignee as herein provided;

**AND WHEREAS** the Assignee is desirous of acquiring the right to use the Trade Marks;

**NOW THEREFORE THIS AGREEMENT WITNESSETH** that in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration now paid by the Assignee to the Assignor, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. The Assignor hereby sells, assigns, and transfers to the Assignee the whole right, title, goodwill and interest of the Assignor in and to the Trade-marks and the registrations thereof, the

same to be held as fully by the Assignee as the same would have been held by the Assignor had this Assignment not been made.

2. The Assignor covenants and agrees with the Assignee, its successors, and assigns, that it will from time to time and at all times hereafter, upon every reasonable request of the Assignee, its successors and assigns, make, do and execute or cause and procure to be made, done and executed all such further acts, deeds or assurances as may be reasonably required by the Assignee, its successors and assigns, for more effectually and completely vesting in the Assignee, its successors and assigns, the Trade-marks hereby assigned and transferred in accordance with the terms hereof.

3. The Assignee hereby appoints Aylesworth LLP whose full post office address in Canada is P.O. Box 124, 18<sup>th</sup> Floor, 222 Bay Street, Toronto, Ontario M5K 1H1 as the firm to which any notice in respect of any application or registration may be sent, and upon which service of any proceedings in respect of any application or registration may be given or served with the same effect as if they had been given to or served upon the Assignor

4. This Agreement shall enure to the benefit of and be binding upon the parties hereto and their respective successors and assigns.
