RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of December 23, 2009 (“Effective Date”) by and between **Specialized Packaging Finance, Inc.**, a Delaware corporation, with an office at 5200 Town Center Circle, Suite 600, Boca Raton, Florida 33486 (the “Secured Party”), and **Specialized Packaging Intermediate Holding Corp.**, a Delaware corporation, with an office at 5200 Town Center Circle, Suite 600, Boca Raton, Florida 33486 (“Intermediate”), **The Specialized Packaging Group, Inc.**, a Delaware corporation, with an office at #7 Laurel Square Park, 3190 Whitney Avenue, Hamden, Connecticut 06518 (“SPG”), **Specialized Packaging Radisson LLC**, a New York limited liability company, with an office at 8800 Sixty Road, Baldwinsville, New York 13027 (“SPR”), **Specialized Packaging Machinery, LLC**, a Georgia limited liability company, with an office at #7 Laurel Square Park, 3190 Whitney Avenue, Hamden, Connecticut 06518 (“SPM”), and **Specialized Packaging Flexo, LLC**, a Kansas limited liability company, with an office at #7 Laurel Square Park, 3190 Whitney Avenue, Hamden, Connecticut 06518 (“SPF”; each of Intermediate, SPG, SPR, SPM, and SPF, a “Grantor,” and, collectively, the “Grantors”).

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement by and between Grantors and the Secured Party dated July 14, 2009 (the “Trademark Security Agreement”), each Grantor granted to the Secured Party a continuing security interest in and to the Trademark Collateral (as defined in the Trademark Security Agreement), including, without limitation, the United States trademark registrations and applications set forth on Schedule I attached hereto, in each case, together with the goodwill associated therewith;

WHEREAS, Grantors and the Secured Party entered into the Trademark Security Agreement pursuant to the terms and conditions of that certain (i) Senior Secured Promissory Note (as amended, supplemented, amended and restated or otherwise modified from time to time, the “Note”) and (ii) Security Agreement (as amended, supplemented, amended and restated or otherwise modified from time to time, the “Security Agreement”);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 14, 2009 at Reel/Frame 004024/0252; and

WHEREAS, Grantors have paid all of their outstanding indebtedness to the Secured Party.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby terminates the Trademark Security Agreement, the Note, and the Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademark Collateral.

The Secured Party represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Trademark Collateral; (iii) it has not recorded or otherwise evidenced its security interest with respect to any trademark, or registration of an application to register any trademark, or any trade name or assumed name owned by either

Grantor, other than those set forth on Schedule I attached hereto, in any jurisdiction throughout the world.

The Secured Party shall take all further actions, and provide to each Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by any of the Grantors to more fully and effectively effectuate the purposes of this Release.
