

ASSIGNMENT OF TRADEMARKS



WHEREAS, this Assignment of Patent Rights is being executed and delivered pursuant to Section 3.2(f) of that certain Asset Purchase Agreement made and entered into as of June 12, 2007, by and between Assignor and Assignee and a certain Order Granting Motion Pursuant to Section 105, 363(b), 363(f) and 365 of the United States Code Approving the Sale of Substantially All of the Debtor Assets Free and Clear of All Liens, Claims and Interests, with Such Liens, Claims and Interests to Attach to the Proceeds of the Sale that was entered in the United States Bankruptcy Court for the Central District of California, Los Angeles Division (Case No. LA 07-13388-AA).

NOW, THEREFORE, in view of the premises herein and for good and valuable consideration, the receipt of which by Assignor is hereby acknowledged, Assignor has agreed to assign and transfer and by these presents does hereby assign and transfer to Assignee its entire right, title and interest in and to the Trademarks, together with the goodwill associated therewith and symbolized thereby, and any and all renewals thereof, together with all rights to sue and recover for past infringement thereof, to have and to hold forever for the sole and exclusive use and benefit of Assignee.



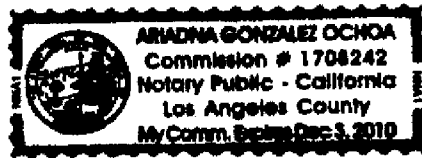
