### TRADEMARK AND DOMAIN NAME ASSIGNMENT

THIS TRADEMARK AND DOMAIN NAME ASSIGNMENT (this “Trademark and Domain Name Assignment”) is made and entered into as of the date of the Intellectual Property Assignment (defined below), by and between **Rock-It Cargo Holdings LLC**, a Delaware limited liability company, with its registered agent’s office at 2711 Centerville Road, Suite 400, Wilmington, DE 19808, **Rock-It Cargo, USA, Inc.**, a Delaware corporation, having a principal place of business at 1800 Byberry Road, Suite 810, Huntingdon Valley, PA 19006, **Rock-It Cargo Cyprus Limited**, a company registered in the Republic of Cyprus with number HE 169116, with its registered office at 11 Florinis Street, City Forum, 7th Floor, 1065 Nicosia, Cyprus, **Rock-It Cargo Worldwide Ltd.**, a company limited by shares organized under the laws of Bermuda, with its registered office at Clarendon House, 2 Church Street, Hamilton HM 11, Bermuda, and **Rock-It Cargo International S.à r.l.**, a company formed under the laws of Luxembourg, with its registered office at 52-54, avenue du X Septembre, L-2550 Luxembourg, Grand Duchy of Luxembourg (collectively referred to herein as “Assignors”) and **Rock-It Cargo USA LLC**, a Delaware limited liability company, having a principal place of business at 1800 Byberry Road, Suite 810, Huntingdon Valley, PA 19006 (“Assignee”). Capitalized terms used but not defined herein shall have the meanings ascribed to such terms in the Intellectual Property Assignment or the Purchase Agreement. To the extent any provision herein is inconsistent with the Intellectual Property Assignment, the provisions of this Trademark and Domain Name Assignment shall control. Unless expressly provided herein, all provisions of the Intellectual Property Assignment are incorporated herein by reference.

**WHEREAS**, Assignors and Assignee have entered into an Intellectual Property Assignment, dated as of December 28, 2009 (the “Intellectual Property Assignment”), pursuant to which Assignors have agreed, *inter alia*, to assign to Assignee and Assignee has agreed to acquire the Trademarks (as defined below) and Domain Names (as defined below).

**NOW, THEREFORE**, in consideration of the promises and the mutual representations, warranties, covenants and agreements set forth in this Trademark and Domain Name Assignment and in the Intellectual Property Assignment, the parties agree as follows:

1. Definitions.

“Domain Names” means the domain names, web site addresses and rights to uniform resource locators that are listed on Attachment A-2 hereto.


2. Assignment.


