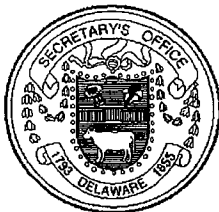

**FOURTH:** The merger is to become effective as of January 1, 2010.


