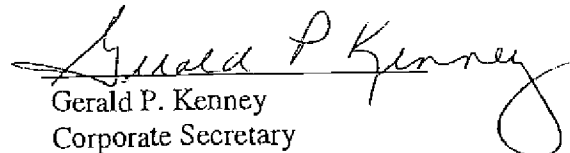
CERTIFICATE OF AMENDMENT
OF
CERTIFICATE OF INCORPORATION
OF
NEC CORPORATION OF AMERICA

IT IS HEREBY CERTIFIED THAT:

1. The name of the corporation is NEC Corporation of America (the "Corporation").
2. The certificate of incorporation of the Company was filed with the Secretary of State of the State of Delaware on the 24th day of February, 1981 under the name NEC Home Electronics, Inc.
3. The certificate of incorporation of the Corporation is hereby amended by striking out Article Fourth, Section 1 thereof and by substituting in lieu of Said Section 1 the following new Section 1:

"FIRST: The name of the corporation is NEC America, Inc."
4. This amendment to the certificate of incorporation was duly adopted by resolution of the Board of Directors in accordance with the provisions of Sections 228 and 242 of the General Corporation Law of the State of Delaware.
5. This amendment shall become effective on September 23, 2009.
