

IT IS HEREBY CERTIFIED THAT:

1. The name of the corporation is NEC Corporation of America (the "Corporation").
2. The certificate of incorporation of the Company was filed with the Secretary of State of the State of Delaware on the 24<sup>th</sup> day of February, 1981 under the name NEC Home Electronics, Inc.
3. The certificate of incorporation of the Corporation is hereby amended by striking out Article Fourth, Section 1 thereof and by substituting in lieu of Said Section 1 the following new Section 1:
