MUTUAL ASSIGNMENT AND ASSUMPTION AGREEMENT

This Assignment and Assumption Agreement is made as of December 1, 2008 between Regent Entertainment Media Inc ("REM"), a Delaware corporation, and Hyperion Media L.L.C., a Texas limited liability company ("Hyperion").

WHEREAS, pursuant to that certain put/call agreement ("Put /Call Agreement") among REM and SpecPub Inc. ("SPI"), Regent Releasing, L.L.C. and PlanetOut Inc and LPI Media Inc., dated as of August 12, 2008, REM acquired Assets, as such term is defined in the Put/Call Agreement, of SPI (the "SPI Assets"). Except as may be otherwise specified herein, all capitalized terms used herein shall have the same meanings given to them in the Put/Call Agreement.

WHEREAS, REM desires to assign the SPI Assets to Hyperion.

WHEREAS, Hyperion desires, by its execution and delivery of this Assignment and Assumption Agreement, to acquire the SPI Assets and to assume the Assumed Liabilities of REM with respect to the SPI Assets.

WHEREAS, Hyperion owns www.gaysports.com and www.shewired.com (the "Web Sites") and desires to assign all of its rights and obligations in the Web Sites to REM.

WHEREAS, REM desires, by its execution and delivery of this Assignment and Assumption Agreement to acquire all of the right title and interest in and to the Web Sites and to assume all obligations thereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. REM Assignment: REM hereby irrevocably sells, grants, assigns and transfers to Hyperion in perpetuity throughout the Universe, all of REM's right, title and interest in and to all of REM's rights in and to the SpecPub Assets, including without limitation those assets listed on Schedule A attached hereto and incorporated by reference, and all equipment, materials, supplies, furniture, fixtures, improvements and other tangible assets of SPI; all advertising and promotional materials owned by SPI; all Print Business IP, to the extent assignable as contemplated under Section 6.7(a) of the Put/Call Agreement; all rights of SPI under the Print Agreements, to the extent assignable; all Government Authorizations held by SPI; all claims (including claims for past infringement or misappropriation of Intellectual Property or Intellectual

Property Rights but excluding claims related to the Excluded Assets) and causes of action of SPSI against other Persons (regardless of whether or not such claims and causes of action have been asserted by SPI), and all rights of indemnity, warranty rights, rights of contribution and rights to refunds (but excluding such rights relating to the Excluded Assets), rights of reimbursement and other rights of recovery possessed by SPI (regardless if whether such rights are currently exercisable); all inventory, prepaid expenses, accounts receivable and other current assets of SPI; all books, records, files and data of SPI, excluding the employment records of each Print Employee; Copyrights, Copyright Registrations, all derivative works and other works protectable by copyright included in the Assets, which are presently, or in the future may be, owned, created (as a work for hire for SpecPub), authored (as a work for hire for the benefit of SpecPub), or acquired by SpecPub, in whole or in part, and all Copyrights thereto; and all Copyright Registrations therefore, heretofore or hereafter granted or applied for and all renewals and extensions thereof, throughout the world; Trademarks, Trademark Registrations, Trademark Rights, URLs, internet domains and web sites included in the SpecPub Assets, and all results and proceeds thereof.

2. Assumption by Hyperion: Hyperion hereby assumes all obligations owed by REM with respect to the SpecPub Assets.

3. Hyperion Assignment: Hyperion hereby sells, grants, assigns and transfers to REM forever, in perpetuity throughout the Universe, all of Hyperion's right, title and interest in and to the Web Sites, including without limitation all copyrights, copyright registrations, all derivative works and other works protectable by copyright which are presently, or in the future may be, owned, created (as a work for hire for Hyperion), authored (as a work for hire for the benefit of Hyperion), or acquired by Hyperion, in whole or in part, and all copyrights thereto and all copyright registrations therefore, heretofore or hereafter granted or applied for and all renewals and extensions thereof, throughout the world; trademarks, trademark registrations, trademark rights, trademarks, applications, assignments and the results and proceeds of the Web Sites.

4. Assumption by REM: REM hereby assumes all obligations owed by Hyperion with respect to the Web Sites.

5. Representations, Warranties and Indemnities.

(a) Hyperion and REM each represent and warrant that it has the right, power, legal capacity and authority to enter into this agreement.

(b) Hyperion and REM shall defend and indemnify and hold the other harmless of and from any and all claims, damages, liabilities, actions, causes of action, costs and expenses (including attorneys' fees) incurred by reason of, or arising out of, or in connection with, the performance of the Assignment and Assumption Agreement and the undertakings assumed herein ("Claim"), except from any Claim caused by a defective transfer of title to the other party, as to which each party hereby indemnifies the other.

(c) REM and Hyperion both agree to execute, acknowledge and deliver any and all further documents which may be necessary to effectuate the purposes of this Assignment and Assumption Agreement.

6. Miscellaneous. This agreement shall be binding upon and inure to the benefit of the successors, assignees and licensees of the parties. This agreement shall be construed and enforced in accordance with the internal laws and decisions of the State of California.

IN WITNESS WHEREOF, the parties to this agreement have duly executed it as of the date and year first above written.


