ASSIGNMENT OF SERVICE MARKS AND TRADEMARKS

This ASSIGNMENT OF SERVICE MARKS AND TRADEMARKS, is made as of the 1st day of January 2010 by DRUMMOND AMERICAN LLC, an Illinois limited liability company, with its principal place of business at 600 Corporate Woods Parkway, Vernon Hills, Illinois 60061, U.S.A. ("Assignor"), to LAWSON PRODUCTS, INC., an Illinois corporation, with a principal place of business at 1666 East Touhy Avenue, Des Plaines, Illinois 60018, U.S.A. ("Assignee").

RECITAL

Assignee, formerly Drummond American Corporation, Illinois corporation #51102371, was merged as of January 1, 2009, into Drummond American LLC ("Assignor") and agrees to transfer to Assignee, and Assignee agrees to receive from Assignor, all intellectual property owned by Assignor, including without limitation the service marks, trademarks, and trade names of Assignor. Assignor agrees to execute such instruments as the Assignee may reasonably request in order to more effectively assign, transfer, grant, and convey the intellectual property to Assignee and its successors and assigns.

In accordance herewith, Assignor desires to transfer and assign to Assignee, and Assignee desires to accept the transfer and assignment, of all of Assignor's worldwide right, title, and interest in, to, and under Assignor's registered and unregistered domestic and foreign service marks, trademarks, trademark applications, and trade names, including without limitation the service marks, trademarks, service mark and trademark applications, and trade names listed on Schedule A annexed hereto corresponding to the "United States Marks," and Schedule B annexed hereto corresponding to the "Canadian Marks." Schedule A and Schedule B are incorporated herein by reference (the United States Marks and the Canadian Marks being referred to herein collectively as the "Marks").

NOW, THEREFORE, Assignor does hereby transfer and assign to Assignee, and Assignee hereby accepts the transfer and assignment, of all of Assignor's worldwide right, title, and interest in, to, and under the Marks, together with the goodwill of the business associated therewith and which is symbolized thereby, all rights to sue for infringement of any of the Marks, whether arising prior or subsequent to the date of this Assignment of Service Marks and Trademarks, and any and all renewals and extensions thereof that may hereafter be secured under the laws now or hereafter in effect in the United States, Canada, and in any other jurisdiction, the same to be held and enjoyed by Assignee, its successors, and assigns from and after the date hereof as fully and entirely as the same would have been held and enjoyed by the said Assignor had this Assignment of Service Marks and Trademarks not been made.

Except to the extent that federal law preempts state law with respect to the matters covered hereby, this Assignment of Service Marks and Trademarks shall be governed by and construed in accordance with the laws of the State of Illinois without giving effect to the principles of conflicts of laws thereof.

IN WITNESS WHEREOF, Assignor has caused its duly authorized officer to execute this Assignment of Service Marks and Trademarks as of the date first above written.


